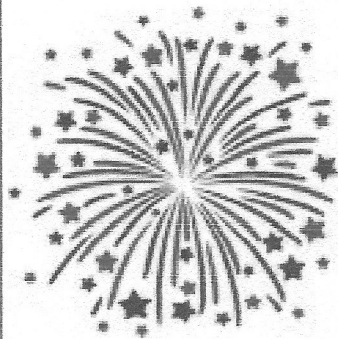

### Burn Pile

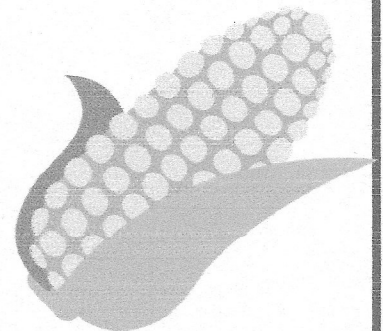
The burn pile is for brush and branches ONLY, no other items may be left there.

**VOTING BY ABSENTEE BALLOT**  
**Partisan Primary Election – August 11, 2020**

Any qualified elector who is unable or unwilling to appear at the polling place on Election Day may submit a request to vote an absentee ballot to their municipal clerk. A qualified elector is any U.S. citizen, who will be 18 years of age or older on Election Day, who has resided in the ward or municipality where he or she wishes to vote for at least 10 consecutive days before the election. The elector must also be registered in order to receive an absentee ballot. Proof of identification must be provided before an absentee ballot may be issued.

You must make a request for an absentee ballot in writing or online at [MyVote.wi.gov](http://MyVote.wi.gov).

Contact your municipal clerk and request that an application for an absentee ballot be sent to you for the primary or election or both. You may also submit a written request in the form of a letter or you may apply for an absentee ballot online at [MyVote.wi.gov](http://MyVote.wi.gov). Your written request must list your voting address within the municipality where you wish to vote, the address where the absentee ballot should be sent, if different, and your signature. You may make application to your municipal clerk for an absentee ballot in person, by mail, by fax, by email or at [MyVote.wi.gov](http://MyVote.wi.gov).

**Making application to receive an absentee ballot by mail**

The deadline for making application to receive an absentee ballot by mail is:  
August 6, 2020

**Note:** Special absentee voting application provisions apply to electors who are indefinitely confined to home or a care facility, in the military, hospitalized, or serving as a sequestered juror. If this applies to you, contact the municipal clerk regarding deadlines for requesting and submitting an absentee ballot.

**Voting an absentee ballot in person**

You may also request and vote an absentee ballot in the clerk's office or other specified location during the days and hours specified for casting an absentee ballot in person.

No in-person absentee voting may occur on the day before the election.

The municipal clerk will deliver voted ballots returned on or before Election Day to the proper polling place or counting location before the polls close on August 11, 2020. Any ballots received after the polls close will not be counted.

## Notice to Reeseville Water & Sewer Utility Customers

We have some exciting news! The Village has partnered with Softline Data (UBMax) to upgrade our Water & Sewer Utility billing system. You will notice some changes when you receive your 2<sup>nd</sup> quarter utility bill. (Don't fret, our rates have not changed!) With the switch to the new program, we now able to offer a Customer Portal where you can make payments and see your account history online.

An EXAMPLE of the new billing postcard is pictured below. The image does not reflect the Village's rates or billing items. The new layout is easier to read and understand. In the past, the payment stub was perforated on the left side of the billing card, the payment stub is now located on the bottom of the card (note the arrow).

Utility payments can still be made by mail, by using the drop box located in front of Village Hall or by credit card, using our new Customer Portal. For online payments, go to [ub-pay.com](http://ub-pay.com) and register with our Municipal Code: **ReesevilleWI579**

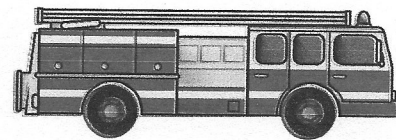
## Blocked Storm Drains

So please be mindful of ordinance Sec. 6-2-11 Unlawful Dumping on Streets "It shall be unlawful for any person to deposit or cause to be deposited, dump, sort, scatter or leave any rubbish, stone, wire, earth, ashes, cinders, sawdust, hay, glass, manure, filth, paper, snow, ice, dirt, grass, leaves, construction waste, garbage or other offensive or noxious material in any public street, sidewalk, alley or upon any public property or upon any property of another, without the express permission of the owner of occupant thereof."

## Joining Forces: The Clyman, Lowell and Reeseville Fire Departments

The Reeseville Fire Department was founded in 1892 with 20 volunteers and a man-powered, hand-drawn chemical and water engine. The engine took 15 men to operate and was capable of throwing four barrels of water per minute. At that time water was drawn by hand and homes still used wood and oil for heating and lighting. There were dozens of businesses in town including a saddle maker, implement dealer, grocer and three bars. Most of the families worked near where they lived in Reeseville.

As it is plain to see, life has changed a little. Not only do we have electricity and running water, fire fighting has also evolved into a modern science requiring extensive training and expensive technical equipment. However, as technology has grown business have closed or moved away. Currently many of the people that live in Reeseville commute to work in another community. This leaves only a few volunteers to respond to daytime emergencies.

With the new challenges of equipment costs and fewer volunteers the Reeseville Fire Department has sought creative solutions. Clyman and Lowell are experiencing similar challenges so the three departments and the surrounding townships, The Town Group, have decided to join forces into one united fire department. As with any new partnership, there are many details to work out, but the first is a new name. The Town Group wants to foster community involvement and is asking citizens for suggested names. Names may be submitted to PO Box 178 or the silver box in front of the village hall. Please include your name along with the suggested Fire Department name. When a name is chosen a winner will be announced and a reward given.

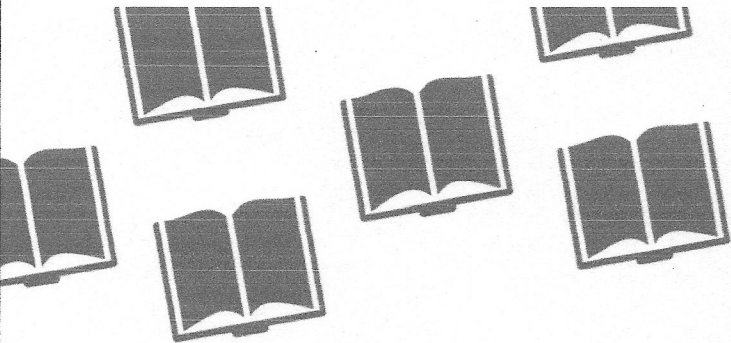


The Summer Reading Program, sponsored by Andrew Mehan, Financial Advisor, started June 15. Turn in reading logs and activity pages for prizes.

## Fourth of July Parade

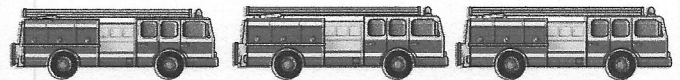
The Reeseville Fire Department is planning a 4th of July parade this year! The firetrucks will drive around town on most streets (not dead end ones) to celebrate Independence Day.

All Christian Education classes are in recess for the summer months and will resume on Sunday, September 13.

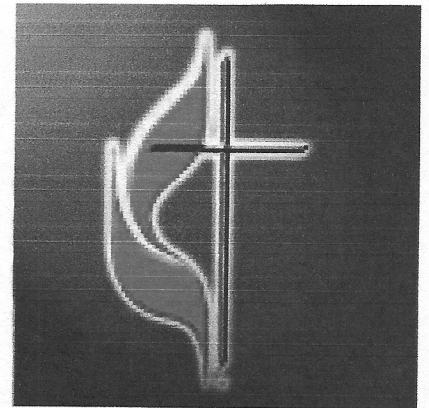

**PROCEEDINGS OF THE VILLAGE BOARD  
OF THE VILLAGE OF REESEVILLE  
June 11, 2020**

A duly convened meeting of the Village Board of the Village of Reeseville, Dodge County, Wisconsin, was held in open session on June 11, 2020 and called to order by Village President, Brian Miller, at 6:30 p.m. The pledge of allegiance was recited. The following Trustees were present, Chris Abell, Jim Bublitz, Cheryl Goodrich, Dave Snow and Grant Rushing. There is one vacant trustee seat.

Notice of this meeting was given to the public at least 24 hours prior to the meeting by posting the complete agenda at the Reeseville Village Hall, the Reeseville Post Office, and on the Village's official website.

There were no public comments or input.

Appointment to fill the vacant trustee seat was tabled, there were no interested parties.

The consent agenda was approved on a motion by Jim Bublitz and seconded by Chris Abell. Motion carried. The consent agenda included approval of the general fund treasury report, the utility treasurer's report and the meeting minutes from the previous Board meeting.

Tammy Hampton, from Kunkel Engineering, was present to discuss the resolutions and ordinance needed for the submittal of the CDBG application. Resolution 2020-4 "Authorizing Resolution to Submit Community Development Block Grant Applications for the Village of Reeseville" was passed on a motion by Dave Snow and seconded by Jim Bublitz. A roll call vote was taken; Chris Abell -yes, Jim Bublitz -yes, Cheryl Goodrich -yes, Dave Snow -yes, Grant Rushing -yes and Brian Miller -yes. Motion carried (6-yes, 0-no, 1-vacancy). Resolution 2020-5 "Authorizing Resolution to Commit Matching Funds for the Village of Reeseville, WI" was passed on a motion by Jim Bublitz and seconded by Cheryl Goodrich. A roll call vote was taken; Chris Abell -yes, Jim Bublitz -yes, Cheryl Goodrich -yes, Dave Snow -yes, Grant Rushing -yes and Brian Miller -yes. Motion carried (6-yes, 0-no, 1-vacancy). Matching funds will be obtained through a loan with Farmers & Merchants State Bank at an interest rate of 2.25%, payable over ten years. Ordinance A-102 was repealed and replaced with Ordinance A-127 "An Ordinance Repealing and Recreating Title 15 Building Codes, Chapter 3 Fair Housing, of the Village of Reeseville Municipal Ordinances for the Purpose of Adopting Wis. Stats 106.50, as Amended, Relating to the Equal Rights of All persons to Fair Housing, and Providing Means for the Implementation and Enforcement Thereof" was adopted on a motion by Cheryl Goodrich and seconded by Chris Abell. A roll call vote was taken; Chris Abell -yes, Jim Bublitz -yes, Cheryl Goodrich -yes, Dave Snow -yes, Grant Rushing -yes and Brian Miller -yes. Motion carried (6-yes, 0-no, 1-vacancy).

Tammy gave a brief engineer's report. A contractor will be back to fix the landscaping on Lincoln Street and North Avenue from the 2018 utility improvement project. Kunkel Engineering will inspect the work following completion. Cost estimates to replace the sanitary sewer on Pearl & Emerald Street will be available soon.

Police Chief Bahr gave the monthly police report. Citations issued, repairs to the squad, citizen complaints and calls for service for the month were reviewed by the Board. Discussion was then had on the squad car. The car has had several repairs, year to date, with the next repair potentially costing over a \$1,000. Chief Bahr was asked to get quotes on used vehicles and obtained a quote from Ewald for a new squad. Ewald has two new squads on order and should be delivered by August or September. The quote from Ewald was \$33,566. Motion by Jim Bublitz and seconded by Chris Abell to purchase a new squad from Ewald, for the quote given. A roll call vote was taken; Chris Abell -yes, Jim Bublitz -yes, Cheryl Goodrich -yes, Dave Snow -yes, Grant Rushing -yes and Brian Miller -yes. Motion carried (6-yes, 0-no,

1-vacancy). Dave Snow handed out a list of property maintenance issues and the police department will make contact with the owners.

Fire Chief Gay was absent, no fire report was available.

Chris Abell gave an update on the First Responders. There were six calls since the last Board meeting, all AEDs have been checked and there is one new recruit from the Village of Lowell. The First Responders will attend the joint fire department training on June 15<sup>th</sup>, for water rescue. The Lifestar EMS report was reviewed.

Dave Snow and Brian Miller attended the Columbus Area EMS Group meeting last month, which governs Lifestar EMS. The Village will be considered to join the group, as a voting member, in January 2021 and it should be a smooth transition.

There was nothing to report on the Residence Board.

There was nothing to report on the Library, they have not yet met for the month.

Dean Ziegel reviewed the 2019 Compliance Maintenance Annual Report, for the sewer utility. The Village received a 4.0, which is the highest score possible. Dean thanked the Board for all that they do to keep the utilities running smoothly. The Board then thanked Dean for all of his hard work. Lead and copper samples are usually due to the DNR around this time. The DNR had extended the deadline due to the COVID-19 pandemic. Dean is waiting to hear from the State when he can resume collecting samples. Overall, the utilities are doing well, even with recent storms. Resolution 2020-6 "Wisconsin Department of Natural Resources NR208-Compliance Maintenance Resolution for the 2020 Report; Reporting for the year 2019" was approved on a motion by Dave Snow and seconded by Jim Bublitz. Motion carried.

Dean Ziegel also gave a brief update on the streets and alleys. Due to the recent storms and residents blowing grass clippings in the streets, Dean and Gary Kohn have had to clean out the storm drains to prevent blockages. It was also noted that a few large tree limbs fell in the cemetery, one stone was knocked over and Dean is waiting for a quote to right it.

The Board acted on closing Park Avenue for the Tribute Ride on July 25<sup>th</sup>. There will be approximately 150 motorcycles and they will use Park Avenue to rest. The closure will be about an hour long, between 2:00-3:00 pm. Motion by Jim Bublitz and seconded by Cheryl Goodrich to approve the street closure. Motion carried.

Two certified survey maps were reviewed by the Board. The first map is a redivision of lots 1-5 of the sunset crest subdivision and the other map is a redivision of lots 20-22 and lot 37 of the Sunset Crest Subdivision. Motion by Chris Abell and seconded by Jim Bublitz to approve both certified survey maps. Grant Rushing abstained; motion carried.

Farmers & Merchants State Bank offered the Village a loan to purchase the new police squad car at an interest rate of 2%, payable over 5 years, with annual payment installments. Resolution 2020-7 "Resolution for Temporary Borrowing" for the purchase of the police squad car was approved, contingent on adding the purchase amount of \$33,566.00 to be borrowed, on a motion by Jim Bublitz and seconded by Dave Snow. A roll call vote was taken; Chris Abell -yes, Jim Bublitz -yes, Cheryl Goodrich -yes, Dave Snow -yes, Grant Rushing -yes and Brian Miller -yes. Motion carried (6-yes, 0-no, 1-vacancy).

The following license applications for the licensing period of 7/01/2020 - 6/30/2021 were reviewed by the Board: Mobile home park licenses for Reeseville Associates and Sunny Creek Home LLC, were approved on a motion by Jim Bublitz and seconded by Chris Abell. Motion carried. Class B Combination Licenses for Just 1 More LLC and the Reeseville Community Center, were approved on a
