## Village of Reeseville Housekeeping

The Village of Reeseville Board meetings are held on the 2nd Thursday of each month beginning at 6:30 p.m. Public comments are heard for the first 15 minutes of each meeting. All Village residents are welcome. If you wish to add something to the agenda please contact the Village Clerk. Meeting minutes will be printed in this newsletter, however they are not official until approval at the following monthly meeting.

The Village Clerk, Christine Abell, is available to help residents with any village business such as utility or tax payments and ordinance inquiries. She is available by appointment, **9-4 Monday-Friday**.

### Brush and Branch Pickup

1st and 3rd Monday of each month. Brush and leaves must be bagged. Branches need to be a maximum of **4 feet** and tied in bundles. **All branches not tied or longer than 4 feet will not be collected.**

### Burn Pile

The burn pile is for brush and branches **ONLY**, no other items may be left there.

### Blocked Storm Drains

Do not allow lawn clippings to go into the streets. During big rains leaves, sticks and clippings block storm drains around town. If the drains are blocked the rain water may cause flooding and property damage.

## Trick or Treat

The Village Board has set hours of trick or treat for 3-5pm on Saturday, October 31, 2020. Households interested in giving out treats should turn on their porch light. The Board recommended that people should be mindful of maintaining social distancing between groups of trick or treaters and wearing a mask, if possible.



### Notice to Reeseville Water & Sewer Utility Customers

We have some exciting news! The Village has partnered with Softline Data (UBMax) to upgrade our Water & Sewer Utility billing system. You will notice some changes when you receive your 2<sup>nd</sup> quarter utility bill. (Don't fret, our rates have not changed!) With the switch to the new program, we now able to offer a Customer Portal where you can make payments and see your account history online.

An EXAMPLE of the new billing postcard is pictured below. The image does not reflect the Village's rates or billing items. The new layout is easier to read and understand. In the past, the payment stub was perforated on the left side of the billing card, the payment stub is now located on the bottom of the card (note the arrow).

**VILLAGE OF REESEVILLE -DODGE COUNTY, WIS.****VOTING BY ABSENTEE BALLOT  
General Election – November 3, 2020**

Any qualified elector who is unable or unwilling to appear at the polling place on Election Day may submit a request to vote an absentee ballot to their municipal clerk. A qualified elector is any U.S. citizen, who will be 18 years of age or older on Election Day, who has resided in the ward or municipality where he or she wishes to vote for at least 28 consecutive days before the election. The elector must also be registered in order to receive an absentee ballot. Proof of identification must be provided before an absentee ballot may be issued.

**You must make a request for an absentee ballot in writing or online at MyVote.wi.gov.**

Contact your municipal clerk and request that an application for an absentee ballot be sent to you for the primary or election or both. You may also submit a written request in the form of a letter or you may apply for an absentee ballot online at MyVote.wi.gov. Your written request must list your voting address within the municipality where you wish to vote, the address where the absentee ballot should be sent, if different, and your signature. You may make application to your municipal clerk for an absentee ballot in person, by mail, by fax, by email or at MyVote.wi.gov.

**Making application to receive an absentee ballot by mail**

The deadline for making application to receive an absentee ballot by mail is:  
**5 p.m. on October 29, 2020**

**Note:** Special absentee voting application provisions apply to electors who are indefinitely confined to home or a care facility, in the military, hospitalized, or serving as a sequestered juror. If this applies to you, contact the municipal clerk regarding deadlines for requesting and submitting an absentee ballot.

**Voting an absentee ballot in person**

You may also request and vote an absentee ballot in the clerk's office or other specified location during the days and hours specified for casting an absentee ballot in person.

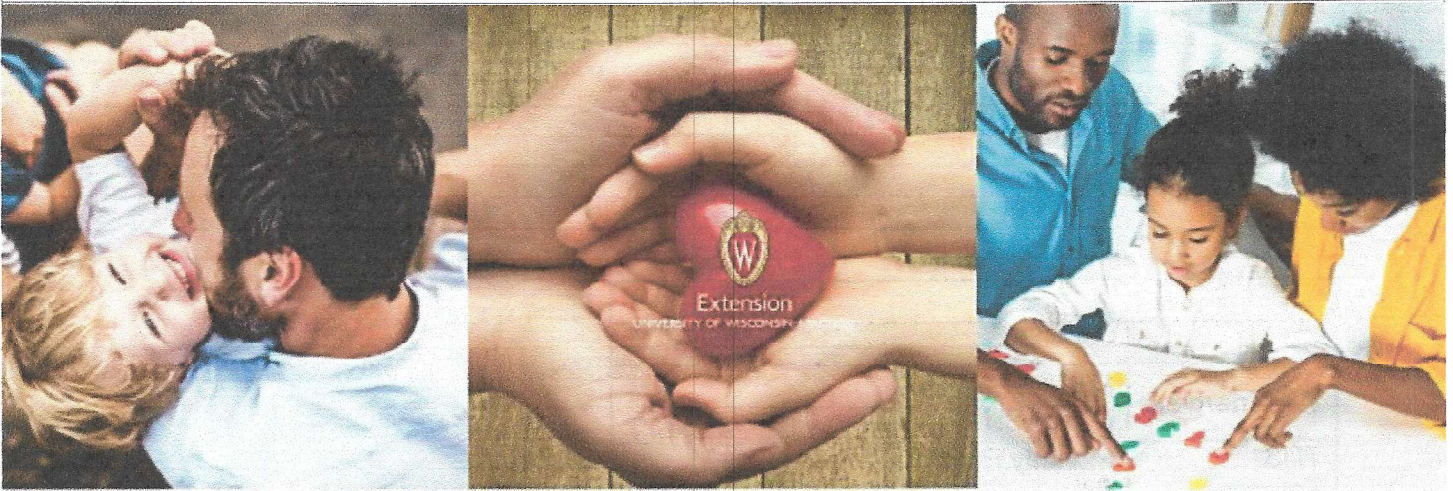
**The last day to vote an absentee ballot in the clerk's office:**

The guidance provides ideas for alternative celebrations, such as:

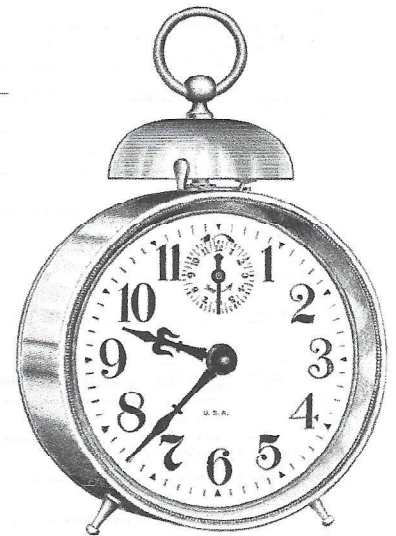
- Virtual costume contests and parties

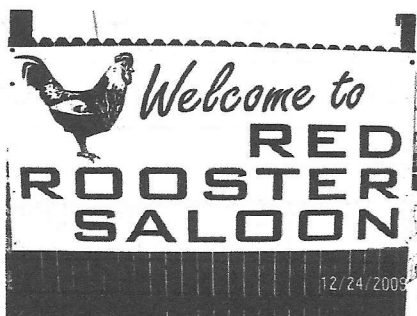
They are known for their fish fries, but they also offer breakfast, sandwiches and daily specials. Karen says that Freddy's American fries are the best around.

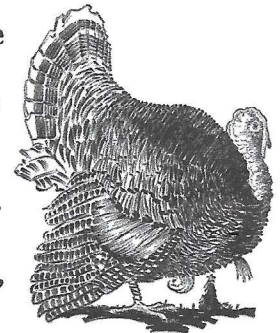

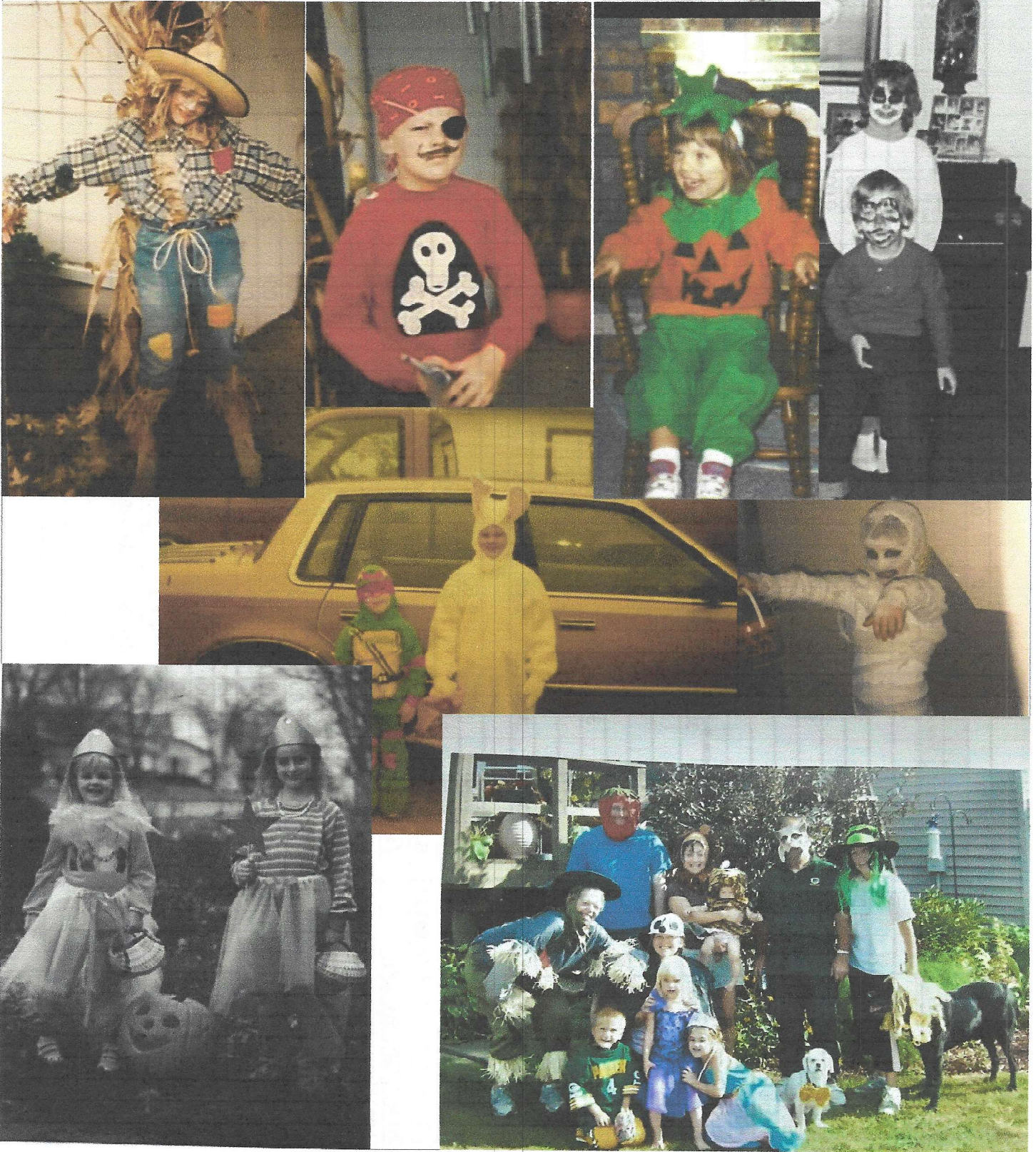

**PROCEEDINGS OF THE VILLAGE BOARD  
OF THE VILLAGE OF REESEVILLE  
September 10, 2020**

A duly convened meeting of the Village Board of the Village of Reeseville, Dodge County, Wisconsin, was held in open session on September 10, 2020 and called to order by Village President, Brian Miller, at 6:30 p.m. The pledge of allegiance was recited. The following Trustees were present, Chris Abell, Jim Bublitz, Cheryl Goodrich, Dave Snow and Grant Rushing. There is one vacant trustee seat.

Notice of this meeting was given to the public at least 24 hours prior to the meeting by posting the complete agenda at the Reeseville Village Hall, the Reeseville Post Office, and on the Village's official website.

There was no public comment or input.

The consent agenda was approved on a motion by Jim Bublitz and seconded by Cheryl Goodrich. Motion carried. The consent agenda included approval of the general fund treasury report, the utility treasurer's report and meeting minutes from the previous Board meeting.

An application to rezone 103 S. Main Street from "Neighborhood Business" to "Residential" was approved on a motion by Jim Bublitz and seconded by Grant Rushing. Motion carried. A hearing took place before the regular meeting to discuss the application and answer any questions or concerns regarding the zoning change.

Jim Bublitz motioned to move up item #17 "Recreation Department Reports and Updates". There was no objection.

Perry Firari was present to discuss the recreation department updates and field use. Perry passed out copies of emails between the recreation department and Cheryl Goodrich. Perry stated that the Waterloo and Watertown baseball teams were allowed to use the field in order to do whatever they can to keep things going this year. For clarification, it was stated that Angie Firari returned to lock up bathrooms and the concession stand after the game(s) were finished. A recent donation was received from the Waterloo Youth Sports Organization to help cover the additional expenses incurred. Watertown will also be issuing a donation in the near future, per Perry. The donations received so far, do not fully cover all additional maintenance costs including additional mowing, electric, water & sewer. Discussion on the recreation director was had. The Finance & Personnel Committee left it up to the Baseball Association to find a new director. To date, there isn't a director and the duties have been split amongst the association members. The Board noted that they would like to have a liaison/director to work with both the Baseball Association and the Village Board. Perry listed many things that the association has done to update the diamonds and field. Brian Miller recognized the association for all that they've done, but they would like more communication on what is happening. There was no further discussion.

The Board returned to item #6 "Engineer's Report & Update".

Tammy Hampton and Don Neitzel from Kunkel Engineering, were present via phone to give the engineer's report. The CDBG grant that the Village applied for, for the Jackson Street project was denied. CDBG received more applications than ever before. There are five applications above us at 4 million in project costs. It's unlikely that enough applicants will turn down the grant, so we will reapply next year. Adding in utility work will increase our chances to get the grant next year, Tammy and Don discussed adding in storm sewer work.

Tammy and Don discussed the Park Avenue project. The Village could move forward with reconstructing Park Avenue, now that the Jackson Street project is on hold. The project would cost around

\$400,000. The Village could apply for the PFED grant which matches grant funds, per jobs created. The job creation would be based on Specialty Cheese's expansion. The grant would give \$15-20,000 per job created, but they would only match 50% of the project costs, roughly \$200,000. The TEA grant would also match \$5,000 per job and the Village's TIF could match the remaining \$100,000 needed by taking out a loan. Paul Scharfman stated that he felt comfortable guaranteeing the creation of 20 jobs. The job creation would be split between the Village and an Economic Development (ED) grant for Specialty Cheese. The ED grant would be awarded to the Village and loaned to Specialty Cheese and the loan would become forgivable if the jobs were created within two years and maintained for an additional three years. The potential ED grant would be \$70-\$100,000 if the job creation is split between the ED grant and the Park Avenue project.

Paul Scharfman from Specialty Cheese was present to give an update on the expansion. The groundbreaking happened last Friday. The expansion will add enough capacity to double production. They are hopeful to be adding 100 additional jobs, but can't guarantee a time line on that. The expansion affects the East and South ends of the building. Paul gave a brief update on how the pandemic affected their company.

Discussion was had on the potential Wastewater Treatment Agreement and Developers Agreement. If the Village moves forward with the PFED and/or the ED grant, we will need a developer's agreement. Don stated that the Wastewater Treatment Agreement needed to be revised based on the expansion and proposed new limits. Dean Ziegel and Brian Miller noted a need to include possible fines for sewer clogging or damages to the sewage system due to grease or misc. items sent down the sewer lines. There was a recent event that the sewer main by Specialty Cheese was completely plugged due to grease, masks, hairnets and gloves sent down the sewer. The Board would like to have an updated Wastewater Treatment Agreement executed prior to completion of the expansion.

Tammy noted that the Safe Drinking Water application was submitted in June. The DNR rescored the application from 42 points to 32 for the Pearl Street project. All applicants receive funding, but the Village will not receive principal forgiveness. The village will apply next year for the Clean Water Fund and should be able to get principal forgiveness.

The Board revisited discussion on the Park Avenue project. The general concern with reconstructing Park Avenue is increasing the Village's debt. Park Avenue is not considered a high priority and the Board decided to concentrate on Jackson Street next year and will revisit reconstructing Park Avenue after that project is complete.

Police Chief Bahr gave the monthly report. The report included the hours worked, patrol activity, miscellaneous duties and citizen complaints/calls for Service. Chief Bahr noted that the new squad was found to have a water leak in the rear passenger cargo window and has been taken to the dealer to be repaired.

There was brief fire report. It was stated that the Engine has been repaired and is back in service. There are three new members and at the last training they had, all but one member attended. BINGO has been cancelled for September and the fate of October's BINGO will be determined at a later date.

The Board discussed the Fire Chief position, currently Chief Gay is on unpaid administrative leave. The Fire Commission has been waiting to act on the position and wanted to wait until the potential Clyman, Lowell, Reeseville Department merger was done. The merger is still in the early stages and may not happen until 2022. There was a motion by Grant Rushing and seconded by Cheryl Goodrich to make the recommendation to the commission to act on the Chief's position and not to wait.

There was no First Responder Report. The Board reviewed the Lifestar EMS report, which had six calls for the month of August. There was discussion the Columbus Area EMS Group Intergovernmental Agreement. Resolution 2020-9 "Resolution for Authorization to Execute the Sith

Amendment to the CAEMS Intergovernmental Agreement” was approved on a motion by Chris Abell and seconded by Jim Bublitz. Motion carried.

The Board set the trick or treat hours for 3-5 p.m. on Saturday, October 31, 2020. The following recommendations were made: households interested in giving out treats should turn on their porch light(s). Trick or treaters should be mindful of maintain safe social distancing between groups and wear a mask, if possible.

There was nothing to review on the Residence Board.

The Library report was reviewed by the Board, there was no discussion.

Discussion was had on the payment drop box. The Clerk-Treasurer suggested upgrading the box and showed the Board an example of what she was looking for. The Box has a place for payments to be deposited, but also has a place to leave standard forms. Since there are no official office hours, forms for dog licenses, building permits and general information can be left in the box for residents to take. Motion by Chris Abell and seconded by Jim Bublitz to purchase a new drop box. Motion carried.

Dean Ziegel reiterated the situation regarding the clogged sewer main at Specialty Cheese. Dean has contracted with The Expeditors to do Spring and Fall cleaning and televising for the sewer main by Specialty Cheese.

Dean stated that Dodge County Highway Department reached out to him about striping their parking area at the new building and they would be billed for the time and supplies. Motion by Dave Snow and seconded by Chris Abell to approve the work. Motion carried.

There was discussion on the need for a dead-end/no outlet sign for Emerald/Ruby Street. There has recently been a lot of traffic and U-turns made at the dead end of Ruby Street. According to Google Maps and other Navigation systems, Ruby shows as a through street, connecting to Opal. There was a motion by Jim Bublitz and seconded by Cheryl Goodrich to approve a Dead-End/ No Outlet sign to be placed on Emerald Drive. Motion carried.

Seal coating was recently completed on Commerce Drive, Danville Road and part of Firehouse Drive. The project funding was fronted by Caine Warehousing to be reimbursed in 2021. The Board discussed the potential sale of the old DPW truck and use the funds to cover the road project. Jeff Caine showed interest in trading some of the Seal coating costs for the truck. Motion by Cheryl Goodrich and seconded by Dave Snow to allow Jim Bublitz to work out an agreement with Jeff. Motion carried.

The Board also discussed what to do with the old Police squad. There was a motion by Cheryl Goodrich and seconded by Chris Abell to sell the old squad. Motion carried. The squad will be featured in the Newsletter to be sold by highest bid. The minimum bid begins at \$2,000.00 Bids will be accepted October 1<sup>st</sup> through the end of the month. The sale will go to the highest bidder.

The budget planning date was set for October 15, 2020 at 6:30 p.m.

Dave Snow gave an update on the property maintenance issues. The list is being worked on and progress has been made.

There was no update on the Code Book project.

Dave also noted that many properties were missed at the last garbage collection day.

The locking push bar for the Village Hall door was discussed. Per Chris Abell, with the authorization from Acting Chief Ben Zechzer, the funds can be taken out of the Fire Department budget.

There was nothing to report on the Community Center.

The board discussed future agenda items.
