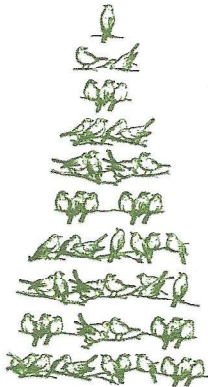

Winter Snow Regulations

Street parking is prohibited 11/15-4/15

between 2am-6am. Tickets will be issued. Please also keep sidewalks clear of snow and salted. It is against village ordinance to purposefully dispense or move snow onto an adjoining property without the owners permission.

Tax Bills

Bills will be mailed around the middle of the month. The Clerk-Treasurer will have temporary office hours at the Village Hall; 206 S. Main Street for tax payments and dog licenses every Wednesday from 9am-1pm beginning December 23 and ending January 27th. Cash payments are accepted but must be exact change, checks are preferred.

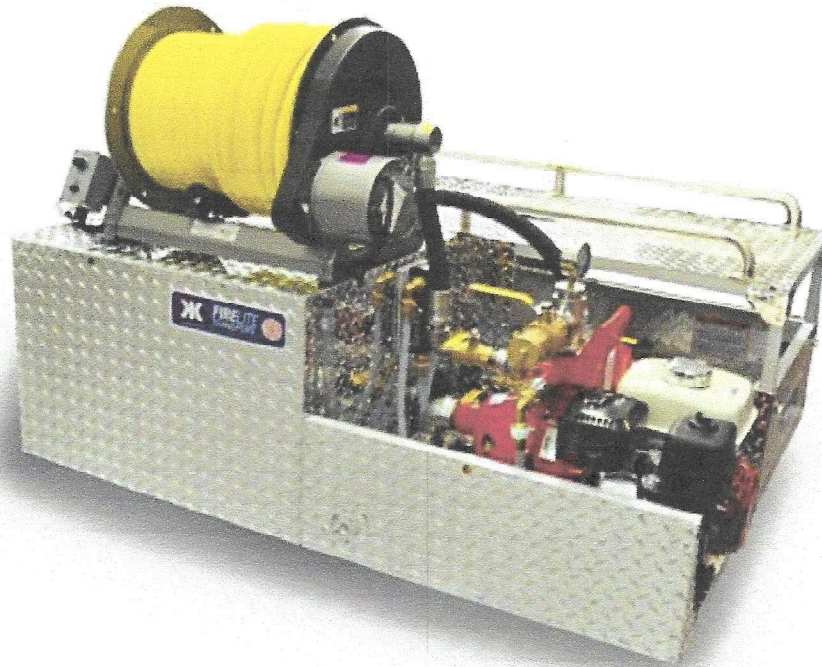

Reeseville Fire Department Receives Two Equipment Grants!

The Reeseville Fire Department recently received a WI DNR matching grant to purchase a new skid unit for our UTV. This unit was purchased for \$9,045 of which the DNR will cover \$4,500; the remainder of the costs were covered by the Reeseville Fire Service Corporation through fundraising and the Reeseville Rural Town Group through the sale of the old skid unit.

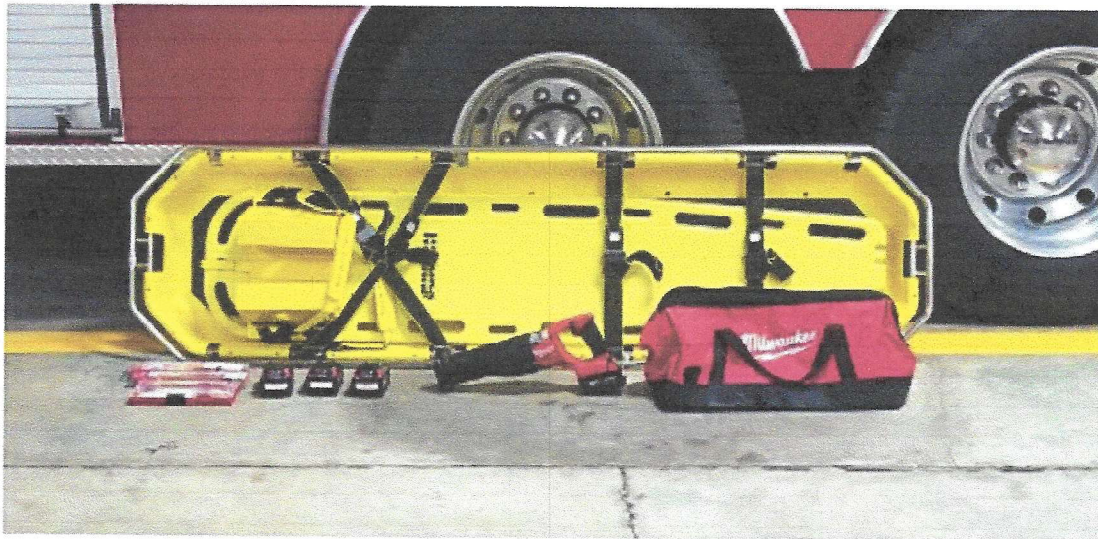
This new skid unit will allow us more versatility in its capability to carry a rescue basket to retrieve and rescue persons. Verses our old skid unit, the new skid unit has larger foam and water tanks, a larger pump & engine, electric start, electric rewind hose reel and an equipment storage area.



The Reeseville Fire Department also recently received a \$2,000 grant from Compeer Financial's Fund for Rural America to purchase a rescue basket (Stokes) package, Sawzall, batteries and blades.

This equipment will allow the Fire Department to more efficiently perform rescues and extrications of trapped or incapacitated persons. The rescue basket works with the new skid unit to help us better rescue persons who are not easily accessible by traditional vehicles. The rescue basket can also be used for high angle rescues such as from the top of grain bins and buildings.

Compeer Financial Awards \$450K to Emergency Response Departments *163 Emergency Response Grants Awarded in IL, MN and WI*

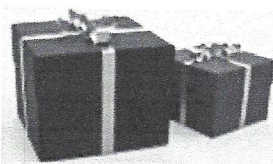

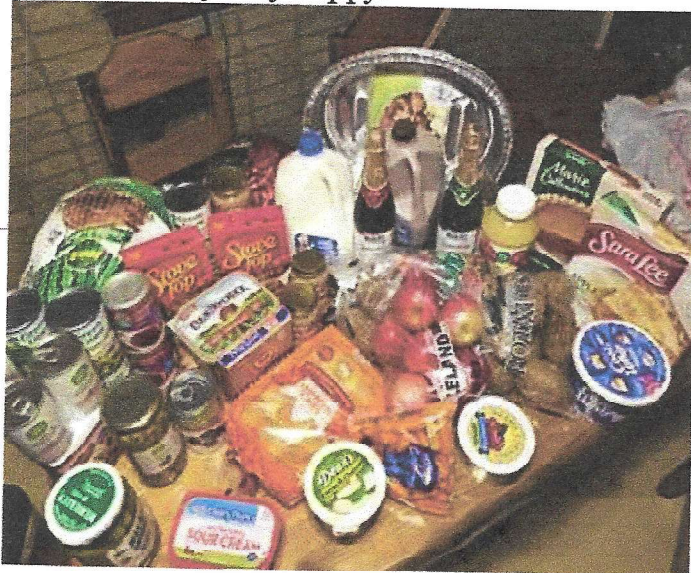

Excerpts from A VETERAN'S STORY: A Time For Christmas
 By Pete Mecca

Christmas, 1914: In the midst of the Great War one of the most bizarre incidents took place on the battlefields of Flanders. While British and French troops watched in amazement from trenches, German soldiers began placing small Christmas trees outside their own trenches across "no man's land." Lit candles adorned the trees. Then the Germans sang Christmas songs with tunes familiar to all belligerents. The French and British soldiers soon joined the singing.

English-speaking German soldiers proposed a Christmas truce. British and French troops readily accepted. The most common message from the Germans was, "We not fight, you no fight." Some British units constructed spur-of-the-moment "Merry Christmas" banners and waited for a reaction. The response was unbelievable.

Sworn enemies left their fighting positions and met in the middle of "no man's land." First, they buried their dead, then exchanged a mishmash of improvised gifts: tobacco, chocolate cake, newspapers, cognac and postcards. A Scot produced a soccer ball which was kicked around with enthusiasm. The game evolved into a regulation football match using caps and helmets laid out as goals. The Germans won, 3-2.

**PROCEEDINGS OF THE VILLAGE BOARD
OF THE VILLAGE OF REESEVILLE
November 12, 2020**

A duly convened meeting of the Village Board of the Village of Reeseville, Dodge County, Wisconsin, was held in open session on November 12, 2020 and called to order by Village President, Brian Miller, at 6:30 p.m. The pledge of allegiance was recited. The following Trustees were present, Chris Abell, Jim Bublitz, Cheryl Goodrich, Grant Rushing and Dave Snow. There is one vacant trustee seat.

Notice of this meeting was given to the public at least 24 hours prior to the meeting by posting the complete agenda at the Reeseville Village Hall, the Reeseville Post Office, and on the Village's official website.

There was no public comment or input.

The Board reviewed two letters of interest for the vacant trustee position from Jim Ricgc and Debby Casperson. Discussion was had regarding the applicants. Motion by Dave Snow and seconded by Cheryl Goodrich to appoint Debby Casperson to fill the vacant trustee position for the remaining term expiring in April 2022. Motion carried.

The consent agenda was approved on a motion by Cheryl Goodrich and seconded by Jim Bublitz. Motion carried. The consent agenda included approval of the general fund treasury report, the utility treasurer's report, minutes from the budget planning meeting and meeting minutes from the previous Board meeting.

Representatives from Kunkel Engineering Group were not available, but an update was received via email and read off by Christine Abell. The update was regarding the 2021 street and utility improvement project and proposed preconstruction timeline. Motion by Dave Snow and seconded by Grant Rushing to move forward with the proposed timeline. Motion carried. A draft Specialty Cheese "Wastewater Treatment and Special Assessment Agreement" was presented to the Board for review. Action was tabled due to additional questions had.

Police Chief Bahr was absent, the Board reviewed the monthly report. No further discussion was had.

Fire Chief Gay resigned at the end of October. The Fire Commission will be taking applications for Fire Chief until November 25th and will interview applicants on December 2nd.

There was no First Responder report.

There was no Residence Board report.

Library Director Kay Kromm was absent, but the Board review the library report. There was no further discussion.

Dean Ziegel gave a brief update on the utilities. The five hydrants scheduled to be replaccd this year will need to go out for bid again. There was no further discussion.

The Board reviewed the proposed 2021 USDA sewer budget. Motion by Jim Bublitz and seconded by Cheryl Goodrich to approve the 2021 USDA sewer budget. Motion carried.

The utility billing software that the Village recently switched to, now offers a public alert system. Residents will be able sign up to receive important notices via phone (call or text) and email. The alerts could be for anything important that needs to get to residents immediately. Motion by Dave Snow and seconded by Debby Casperson to approve purchasing the Alert Messaging level 1. Motion carried.

Dean Ziegel gave an update on the streets. Dean thanked Gary Kohn for his help with leaf and brush pickup and Dave Snow for mulching the leaves in the park. Residents did a great job with piling leaves and brush. The last day for brush pickup is November 16th and the last day for leaf pickup is November 19th. Winter parking regulations will go into effect November 15th. Dave Snow thanked Dean and Gary for the great job they've been doing.

Discussion was had on removing the excess debris from the seal coating. Dean will talk to the County and Jeff Caine about sweeping off the excess debris.

An offer by Jeff Caine to purchase the former DPW truck, a 2009 Ford F250, was reviewed by the Board. The offer proposed an even exchange for the truck and plow for the entire slag seal work on Commerce Drive, Danville Road and portion of Firehouse Dr. Motion by Jim Bublitz and seconded by Dave Snow to accept the offer. Motion carried.

The Village didn't receive any offers on the former police squad. Discussion was had on what to do next. The sale of the squad was tabled.

Resolution 2020-11 "Resolution to Increase the Wages for the Clerk-Treasurer, DPW Superintendent and Utility Treasurer" was reviewed by the Board. Motion by Jim Bublitz and seconded by Grant Rushing to adopt Resolution 2020-11. Chris Abell abstained, motion carried.

Ordinance A-130 "An Ordinance Appropriating the Necessary Funds for the Governing and Administration of the Village of Reeseville for the Year 2021" was approved on a motion by Jim Bublitz and seconded by Cheryl Goodrich. Motion carried.

The Board approved the 2021 Dodge County Humane Society contract for \$1,100 on a motion by Chris Abell and seconded by Jim Bublitz. Motion carried.

No donation was made to American Legion Auxiliary for Christmas bags since the event was canceled this year due to COVID-19.

Dave Snow gave an update on the Public Health and Welfare committee. Chief Bahr had noted that he visited a few properties for junk notices. There was no update on the code book project, the committee needs to meet to review and work on the workbook drafted by General Code. Discussion was had regarding a business in a tax-exempt property that doesn't currently receive garbage/recycling collection services. The Board determined that the business would need to contract with Badgerland directly.

Lawn mowing bidding will need to happen in early 2021. A bidding notice will be placed in the Watertown Daily Times.

The Board discussed issues regarding the baseball field fence. Recently a herd of cattle were on the field due their fence breaking. The cattle fence needs to be moved back off of the Village's property line. There was a motion by Cheryl Goodrich and seconded by Chris Abell to have Kunkel Engineering find and mark the property lines of the baseball field, so further action can be taken at a later date. Motion carried.

Cheryl Goodrich gave a brief update on the Community Center. Spectrum has been temporarily suspended to save money. Some maintenance work needs to be done including trimming up the shrubs and cleaning the gutters. It was brought up that a potential customer was turned away from renting the Community Center, due to the pandemic. Cheryl will check into it; the Community Center Board has not suspended rentals.

There was no Recreation Department report.
