### Brush and Branch Pickup

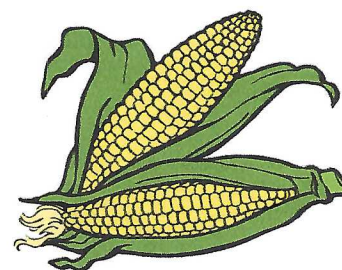

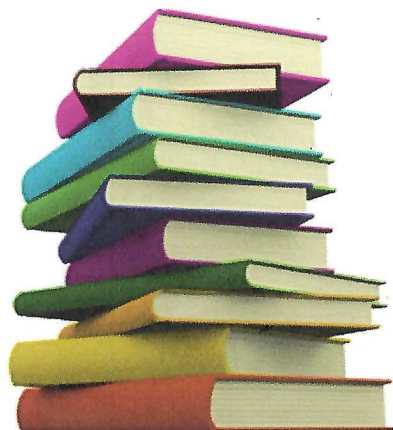

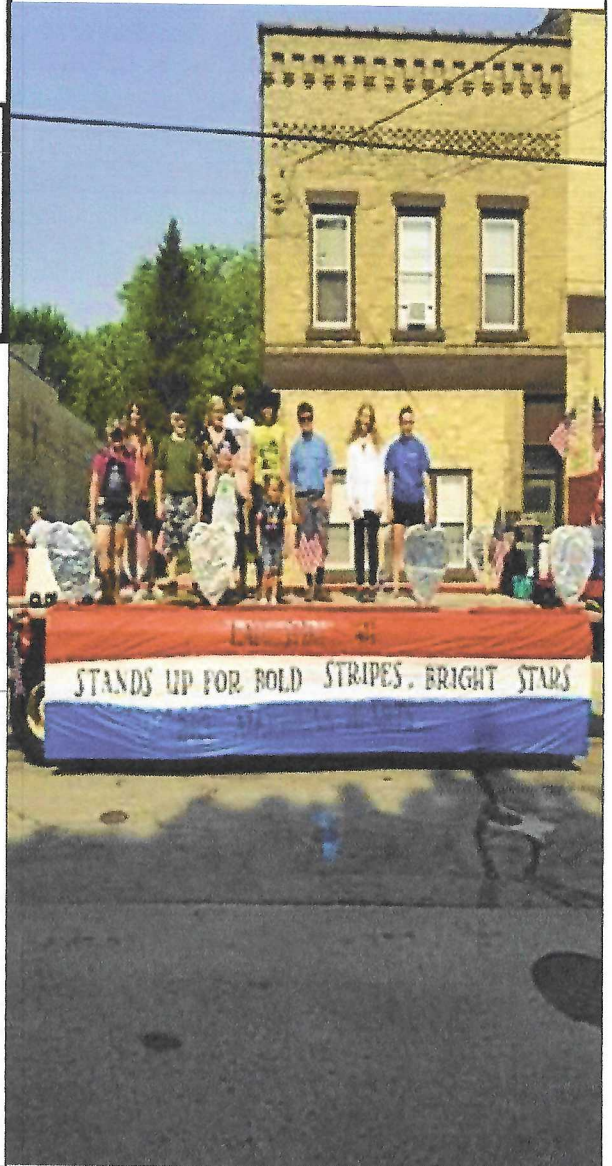

**PROCEEDINGS OF THE VILLAGE BOARD  
FOR POLICE SERVICES HEARING  
July 8, 2021**

A duly convened hearing regarding police services took place in front of the Village Board of the Village of Reeseville, Dodge County, Wisconsin. It was held in open session on July 8, 2021 and called to order by Village President, Brian Miller, at 6:10 p.m. The following Trustees were present, Chris Abell, Jim Bublitz, Debby Casperson, Cheryl Goodrich, Dave Snow and Grant Rushing. There were two residents present.

Notice of this hearing was given to the public at least 24 hours prior to the meeting by posting the complete agenda at the Reeseville Village Hall, the Reeseville Post Office & on the Village's official website

The Board collectively gave statements on why the hearing was called. The Village is having a hard time obtaining part-time officers and has been unsuccessful in recruiting new members. The Village was approached by the Dodge County Sheriff about contracting police services with the county. The Village could contract with the county and stick around the current budget but the hours of coverage would increase. The patrol hours would be flexible to the Village's needs. There would be one to two officers that would be dedicated to serving the village. The Board is hopeful to have more details in the coming weeks.

The residents in attendance expressed concern over the current lack of coverage in the area and would like to have more details regarding the proposed contract with the County. It was stated that they would like to see the police coverage increase whether that means contracting with the County or hiring more part-time members for the Reeseville Police Department.

It was noted that another hearing to discuss the police services will be held on August 12, 2021 at 6:00 p.m.

The hearing adjourned at 6:30 p.m. just prior to the proceedings of the regular Village Board meeting.

**PROCEEDINGS OF THE VILLAGE BOARD  
OF THE VILLAGE OF REESEVILLE  
July 8, 2021**

A duly convened meeting of the Village Board of the Village of Reeseville, Dodge County, Wisconsin, was held in open session on July 8, 2021 and called to order by Village President, Brian Miller, at 6:32 p.m. The pledge of allegiance was recited. Roll call was taken and the following Trustees were present, Chris Abell, Jim Bublitz, Debby Casperson, Cheryl Goodrich, Grant Rushing and Dave Snow.

Notice of this meeting was given to the public at least 24 hours prior to the meeting by posting the complete agenda at the Reeseville Village Hall, the Reeseville Post Office, and on the Village's official website.

There were three village residents present for public comment. The residents wanted to file a complaint with the Village Board regarding excessive noise, property maintenance issues and threatening actions from a neighbor at 400 Prairie Street. A letter from another neighbor, who was not able to attend, was passed around to the trustees in which they attested to the same ongoing issues. Police Chief Bahr was present at the meeting and confirmed that he would follow up with the complaints and contact the property owner at 400 Prairie Street.

There was a motion by Jim Bublitz and seconded by Cheryl Goodrich to approve the consent agenda items, which include the minutes from the previous regular meeting, the Village Treasurer's report and Utility Treasurer's report. Motion carried.

Tammy Hampton from Kunkel Engineering was present to give the Engineer's Report. An update on the Pearl Street project was given. An email from Don Neitzel was read to the Board; all underground utility work, including water and sewer services have been completed. All concrete work consisting of curb and gutter patching and a couple of driveway approaches have been completed with the exception to a few sections that need to be removed and replaced due to the roller or grader and those that have cracks in them. The roadway has been graded and proof rolled and Garnet Circle will require some EBS work. Kruczek is in the process of completing the landscaping and they ran out of topsoil but another load is being delivered. Kartechner, the asphalt contractor, is behind on schedule due to the weather and they will begin paving Pearl Street the week of July 26<sup>th</sup>. The driveways and intersections will be ramped to decrease the drop in street and driveway heights until the streets can be paved.

There was a motion by Dave Snow and seconded by Debby Casperson to approve pay request #3 from Kruczek Construction, in the amount of \$55,772.75 Motion carried.

Police Chief Bahr was present and gave the monthly police report. Chief Bahr went over the hours worked, citations issued and neighbor disputes.

There was no discussion regarding the police services hearing held prior to the regular Board meeting.

Fire Chief Abell gave the Fire Department report. There were five calls in June. BINGO will be held on Sunday. The Fire Department is working on plans for the annual Corn Roast on August 14<sup>th</sup> and it will be a combined effort with the Lowell & Clyman Fire Departments.

Chris Abell also gave a brief update on the First Responders. The committee met on June 24<sup>th</sup> and there were some concerns regarding the First Responders merging with the Fire Department. It was

suggested that the First Responder Committee should take action at their next meeting on their stance regarding the merger. Chief Abell also wanted to state for the record that there are rumors of the Lowell stations doors closing when the merger takes place and that the rumor is not true and there are no plans to shut down that station. It was also noted, the Village of Lowell Board took a general consensus at their last Board meeting in favor of the first responder merger.

There was nothing to report from the Residence Board.

The June library report was reviewed by the Board. Jim Bublitz and Debby Casperson noted that there seems to be a lot of erosion near the outside basement wall. Dean Ziegel stated that Rennhacks will be making repairs to the wall when they work on the storm sewer repairs. There was also discussion on the library's wifi interfering with other internet signals. In the past, it was noted that there was nothing that could be done. Brian Miller will talk to Kay Kromm again and revisit the issue.

Dean Ziegel gave an update on the utilities. Everything seems to be running well. There was a large fire in Lowell and the fire departments used a couple of hydrants in Reeseville as fill stations. It took approximately 100,000 gallons from Reeseville and 200,000 gallons total to extinguish the fire. The water tower will be down for three days while its drained, cleaned and having the mixer installed. They should start within the next couple of weeks. Well 1 needs its normal rehabbing which will cost approximately \$8,002. Dean recently went to WI Rural Water Association training and his water operator license is now recertified until 2024.

Dean Ziegel gave an update on the streets. There was possibly vandalism on Park Avenue. A storm sewer grate was opened and someone (or a group of people) picked up the grate and dropped it into the drain. A few firemen tried to fix the grate when Dean was unavailable but were not able to lift it out of the drain and put up barricades until Dean was able to fix it. It has since been repaired.

Jim Bublitz gave an update on the Finance & Personnel Committee. The committee recently met to discuss how to use the American Rescue Plan Act funds allocated to the Village. The Village will receive approximately \$70,000 in grants from the Federal Government over the next two years. There are very strict eligible uses for these funds. The committee discussed donating some of the money to the Reeseville Fire Service Corp to reinvest it back into the Village Hall/Fire Department by replacing the windows, soffit, gutters and replacing the North side door. Funds could be used to offset the Community Center losses in 2020. The committee will continue to meet and come up with a plan for the funds.

Property maintenance issues were discussed. Chief Bahr noted a couple of properties are starting to make progress. Dave Snow stated he would like to see more progress and citations should be issued if property owners do not comply.

The code book workbook has been converted to the digital format; however, one ordinance still needs further review before the book can be sent back to General Code. The Public Health and Welfare Committee will need to meet for further review.

Jim Bublitz gave an update on the library driveway issues. Jim has spoken with the Caine's and they will bring a truckload of limestone chips to mix with the seal coat in hopes of solidifying it. There was no further discussion.

Brief discussion was had on the baseball fence issue. The field next to the fence was plowed up to the fence line, however, the crops were planted behind the six-foot set back. There was no further discussion or action.

There was nothing to report from the Community Center.

Dean Ziegel noted that the concession stands at the baseball diamonds have been rekeyed. Debby Casperson received an email from Sara Hanna that they would not be hosting the tournament this year. Teresa Chambers reached out to Debby to discuss the possibility of starting up the Baseball Association again next year and having local teams again. There was not further discussion.

A resident recently reached out to ask about potential home delivery to properties on the current rural route. The Columbus Postmaster called the Clerk to discuss what that would entitle and what properties would be eligible. The whole Village would not be eligible for delivery, only properties on Jackson Street, Main Street, Garfield Avenue and portions of Dewy Street and portions of Harrison Street would be eligible for home delivery. These properties are on the rural carrier's route when entering and exiting the Village. Those properties would not get mail delivered to their individual homes; however, they would have to be delivered to a cluster mailbox located on the corner of each eligible street. The Village would be responsible for purchasing and installing each box. Due to the extra stops, they anticipate that the mail would be delivered later and there would potentially be a need to split the rural route. The Board felt that it would be unfair to have home delivery for a few selected streets only and not the entire Village. At this time, the Board decided not to look further into home delivery, there was no further discussion.

Appointment to the Board of Appeals was tabled.

Appointment to the Community Center Board was tabled.

The board discussed future agenda items.
