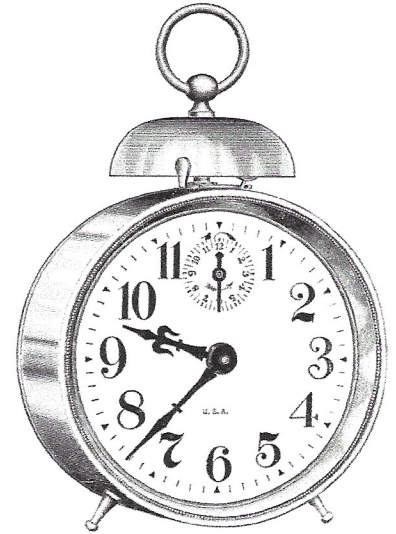

Veterans, Gold Star Families get free entrance to national parks, refuges, other public lands

Entrance fees for the National Park Service and the U.S. Fish and Wildlife Service and standard amenity recreation fees for the Bureau of Land Management, Bureau of Reclamation, U.S. Forest Service and U.S. Army Corps of Engineers sites **are waived for current Military Service-members and their dependents, Veterans and Gold Star Families.** They now have free access to approximately 2,000 public locations spread out across more than 400 million acres of public lands, which host activities to fit any lifestyle, from serene to high octane, including hiking, fishing, paddling, biking, hunting, stargazing, camping, and much more.

Are you eligible?

For purposes of this program, a Veteran is identified as an individual who has served in the United States Armed Forces, including the National Guard and Reserves, and is able to present one of the following forms of valid (unexpired) identification:

- Department of Defense Identification Card
[Veteran Health Identification Card \(VHIC\)](#)
[Veteran ID Card](#)
 - Veterans designation on a state-issued U.S. driver's license or identification card
- Gold Star Families are next of kin of a member of the United States Armed Forces who lost his or her life in a "qualifying situation," such as a war, an international terrorist attack, or a military operation outside of the United States while serving with the United States Armed Forces.
- The America the Beautiful – the National Parks and Federal Recreational Lands Pass (Interagency Pass) Program***

The Interagency Pass Program already includes a free annual pass for active duty members of the U.S. Military and their dependents. Current Military Service-members must show a valid (unexpired) Department of Defense ID. Dependents of current Service-members must show a valid (unexpired) DD Form 1173 AD or DEC.

The annual Military Pass has been expanded to include Veterans and Gold Star Family members. Other free or discounted passes, including some lifetime passes, are available for persons with permanent disabilities, fourth grade students, volunteers, and senior citizens age 62 years or older.

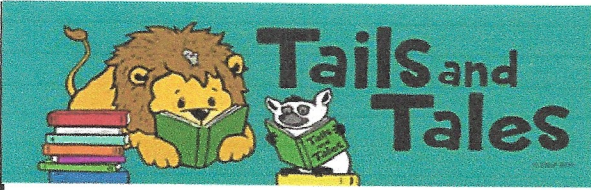
How to get your Interagency Pass

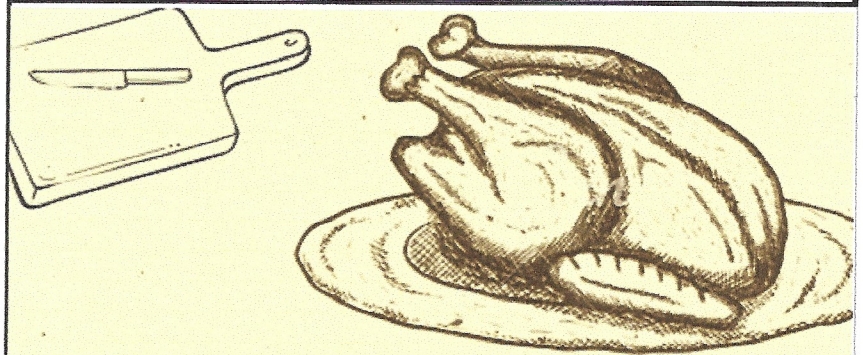
Staff is working hard to keep Take and Make kits in stock. Stop in and see what is available.

The Reeseville Library Board wants to encourage use by forgiving fines. If you have library fines that are keeping you from using the library please contact the director to make arrangements.



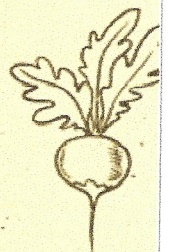

It was established in 1816 by Prussian Emperor Fredrick William III as a day to remember that nation's soldiers who had died in the recently concluded Prussian War. Obviously, it became an important observance in the Evangelical Church in Prussia (established by the same emperor in 1817) as a day to remember not only the war dead, but also church members who had died in the previous year.

This was also the time of clearing gardens and fields of the summer's growth in preparation for winter. To this day, Totenfest in parts of Germany is the day families visit the graves of loved ones to clean off the summer flowers and cover the graves with evergreen boughs for the winter." ----

**PROCEEDINGS OF THE VILLAGE BOARD
OF THE VILLAGE OF REESEVILLE
September 9, 2021**

A duly convened meeting of the Village Board of the Village of Reeseville, Dodge County, Wisconsin, was held in open session on September 9, 2021 and called to order by Village President, Brian Miller, at 7:01 p.m. The meeting had been delayed due to lack of quorum. The pledge of allegiance was recited. Roll call was taken and the following Trustees were present, Chris Abell, Jim Bublitz, Cheryl Goodrich and Dave Snow. Trustees Debby Casperson and Grant Rushing were absent.

Notice of this meeting was given to the public at least 48 hours prior to the meeting by posting the complete agenda at the Reeseville Village Hall, the Reeseville Post Office, and on the Village's official website.

There was no public comment.

There was a motion by Cheryl Goodrich and seconded by Jim Bublitz to approve the consent agenda items, which include the minutes from the previous regular meeting, minutes from the police hearing, the Village Treasurer's report and Utility Treasurer's report. Motion carried.

Andrea Hatton from We-Energies gave a presentation on the LED Conversion Program. A spreadsheet listing all the street light locations and types within the village was reviewed and discussed by the Board. The spreadsheet also listed the upfront conversion fees per pole and the potential future cost savings. If the Village decided to convert all the poles at the same time, the upfront cost would be \$41,770 and the Village would see a return in the investment after seven years. The monthly savings would be \$244.08 per month based on the current day energy rate. Andrea will send out additional information for the Board to review at budget time. There was no further discussion.

Tammy Hampton from Kunkel Engineering was present to give the Engineer's Report. An update was given on the Pearl Street Project. The project is officially done. Kruczek Construction did not submit the final pay request, but pay request #4 was submitted for approval instead. The final pay request is anticipated to be ready for the October meeting. The one-year warranty on the project begins after the final payment is made.

Pay Request #4 for \$173,614.18 was approved on a motion by Jim Bublitz and seconded by Dave Snow. Motion Carried.

Chief Bahr was present to give the police report. The report included the hours worked, citations issued, citizen complaints and calls for service. A new officer, Carmen Micale, was sworn in prior to the Board meeting. Chief Bahr discussed his concerns over the increased truck traffic through the Village due to the closure of County Road M and Highway 16/60. The Board discussed concerns over the deterioration of Jackson Street and the impact the additional traffic will have.

The Protection of Persons, Property & Safety Committee met with the Dodge County Sheriff to discuss police services for the Village. The Sheriff will have a contract drafted prior to the October meeting for the Board to review. A final decision will be made at the October meeting in preparation for the budget meeting.

Chief Abell was present to give the fire report. There were two calls for the month. The merger is progressing and the 2022 CLR Fire & Rescue budget has been drafted. BINGO will be held on Sunday.

Chief Abell also gave an update on the First Responders. The First Responders will be moving forward as part of the CLR merger. The Townships of Portland and Elba have been offered First Responder services starting in 2022 after the merger has been finalized. The two townships will take the offer to each of their Boards for discussion.

The total CLR Fire & Rescue budget is \$191,225. The individual municipalities budget will not change from the current year budget for fire & first responder services. The combined contribution from Reeseville will be \$41,140. There was a motion by Dave Snow and seconded by Jim Bublitz to approve Village's contribution to the CLR Fire & Rescue Group. Chris Abell abstained; motion carried.

The Board set the hours for the Village wide Trick-or-Treat. On a motion by Dave Snow and seconded by Jim Bublitz, the date was set for Sunday, October 31st from 3-5 p.m. Motion carried.

A land division request for N3146 County Road G was reviewed by the Board. The Board had questions regarding a note about a possible driveway easement. There was a motion by Jim Bublitz and seconded by Chris Abell to deny the request due to lack of information available. Motion carried.

There was nothing to report from the Residence Board.

The monthly library report was reviewed by the Board. There was no further discussion.

Dean Ziegel gave an update on the utilities. The Specialty Cheese lift station had issues and needed to be cleaned. The lift station generators had routine maintenance done. The pump at Well #1 is down for a week while its having routine maintenance done.. Brief discussion was had on the need for raising sewer utility rates. The Utility Committee will meet for further discussion on that.

A draft ordinance prohibiting motor vehicle compression brakes was reviewed by the Board. The draft will be revised to include a penalty and the finalized ordinance will be presented at the October meeting.

Discussion was had on the repairs needed for Jackson Street. An unofficial quote of \$77,000 for blacktop grinding and repaving was given. The quote does not include possible culvert repairs needed. The Streets & Alleys Committee will meet to discuss more options.

The budget planning meeting was scheduled for Thursday, October 21st at 6:30 p.m.

A mobile home park license transfer for Reeseville Associates LLC was approved by Jim Bublitz and seconded by Cheryl Goodrich. Motion carried.

The Finance & Personnel Committee recently met to discuss employee wages and salaries. The committee discussed raising the President's salary to \$1,800 per year, \$360 per year with \$50 per monthly Board meeting for Board Trustees and raising the DPW part-time employees' wages to \$15 per hour. More discussion will be had at the budget meeting.

There was no update or report from the Public Health & Welfare Committee.

Debby Casperson was absent, but it was noted that discussion regarding starting up the Recreation Department will happen this winter.

Repairs to the First Responder/Police building were discussed. A gutter needs to be fixed and ice cleats should be installed to avoid ice damming in the future. The DPW office should also have ice cleats

installed to avoid future damage. There was a motion by Chris Abell and seconded by Jim Bublitz to fix the gutter and install ice cleats on the First Responder/Police building and to install ice cleats on the DPW office. Motion carried. A quote will also be obtained on installing heat tape for both buildings. There was no further discussion.

Cheryl Goodrich gave an update on the Community Center. The broken window pane will be repaired soon and the pane has been ordered. The Community Center Board has started talking about the possibility of fish fries in the future.

There was no Recreation Department update or report.

An appointment to the Community Center Board for a two-year term was tabled.

The board discussed future agenda items.
