

#### **Leaf Pickup**

Leaf Pickup will be done on Monday and Thursday each week (weather permitting) and ending on November 18th. Please pile leaves as close to the curb, without being in the street and avoid piling around trees, light posts, signs & vehicles. If vehicles are parked in front of the leaf piles, the Public Works Department will not be able to move around them and your property will be skipped.

#### Winter Snow Regulations

Street parking is prohibited November 15-April 1, between 2am-6am. Tickets will be issued. Please also keep sidewalks clear of snow and salted. It is against village ordinance to purposefully dispense or move snow onto an adjoining property without the owners permission.

#### **Burn Pile**

The burn pile is for brush and branches ONLY, no other items may be left there.

#### **Trash Collection**

The Village Board would like to remind everyone to put trash cans out no more than 24 hours before scheduled collection. Cans should be brought in as soon as possible. Badgerland requests that cans be three feet apart so they can pick up the cans without knocking other cans over.

Hear Ye! Hear Ye! Join us for the Dodgeland 2021 Musical: Once Upon a Mattress!



Rom 10:14 How then shall they call on him in whom they have not believed? And how shall they believe in him of whom they have not heard? and how shall they hear without a preacher?


Some will ask, "will you accept Jesus as your Savior?" But I will ask, "do you know Him?" because that might be the greatest qualifying aspect of Salvation!

#### PROCEEDINGS OF THE VILLAGE BOARD OF THE VILLAGE OF REESEVILLE October 14, 2021

A duly convened meeting of the Village Board of the Village of Reeseville, Dodge County, Wisconsin, was held in open session on October 14, 2021 and called to order by Village President, Brian Miller, at 6:30 p.m. The pledge of allegiance was recited. Roll call was taken and the following Trustees were present, Chris Abell, Jim Bublitz, Debby Casperson (virtually), Cheryl Goodrich, Grant Rushing and Dave Snow.

Notice of this meeting was given to the public at least 48 hours prior to the meeting by posting the complete agenda at the Reeseville Village Hall, the Reeseville Post Office, and on the Village's official website.

There were thirteen people in attendance for public comment. President Brian Miller made an announcement prior to opening up for public comment. A rumor has been going around that the library was being defunded and potentially closing. There have not been any Board discussions about the aforementioned and the rumor is just that, a rumor. Discussion was turned over to the public. Kay Kromm, Library Director, said she was contacted about the rumor and she in turn contacted supporters of the library for help and advice. Many of which have sent letters of support and/or are present at the meeting. Several more comments in support of the library were made by those in attendance. Josh Burbach had questions regarding the baseball park and offered to step in and start up the recreation department. David Koch has a residence on Garnet Circle. David had complaints regarding the condition of his property after the construction finished. His property had been inappropriately used as an access to Garnet when the intersection was impassable during construction. The ramps used on his property caused damage and was not properly fixed. He stated that he is giving Kruczek's and the Village eight months to correct the landscaping. There were no other public comments.

There was a motion by Chris Abell and seconded by Cheryl Goodrich to approve the consent agenda items, which include the minutes from the previous regular meeting, the Village Treasurer's report and Utility Treasurer's report. Motion carried.

Matthew Faust was present to discuss his letter of intent for N3146 County Road G., Reeseville. The original request was not very detailed and the Board denied based on lack of information. Mr. Faust explained that there's a drainage ditch on the property and in order to access the rest of the property, a driveway easement was necessary. There was a motion by Jim Bublitz and seconded by Cheryl Goodrich to approve the letter of intent. Motion carried.

Paul Scharfman, land owner, was present with Donna Braun from the Dodge County Housing Authority to discuss a potential project. Paul would like to lease his land to the Housing Authority for a low-income housing development and childcare. Tonight's presentation is considered the prepetition conference. The proposed project would have ten units with solar panels, energy efficient appliances and affordable childcare. There is a similar development in Horicon. Three acres of Paul's land would need to be zoned as PUD (Planned Unit Development). It is unknown at this time if the 8-acre parcel will need to be subdivided for this use. The units would be owned and maintained by the Housing Authority and the land would be on a long-term lease from Paul. The current timeline is tight. Applications for the Neighborhood Investment Grant are due November 4<sup>th</sup> with the remaining financial application due December 10<sup>th</sup>. Jeff Caine from the Dodgeland School Board and Annette Thompson, Dodgeland District Administrator were present in support of the development. Annette passed out a letter of support on behalf of the Dodgeland School District which also outlined enrollment data trends. Tina Crave, President and CEO of the Greater Watertown Community Health Foundation, was also present in support of the

housing development citing a need for affordable housing. There was a motion by Jim Bublitz and seconded by Cheryl Goodrich in favor of supporting the housing development. This support does not guarantee final approval of the development, but allows the plans to move forward to step two "Petition for Approval". Motion carried. The "Petition for Approval" will be held at the special Board meeting on Thursday, October 21st. At that time, the Board will determine if the plans can move forward for a hearing and final approval at the November 11th Board meeting.

Tammy Hampton from Kunkel Engineering was present for the engineer's report. The final pay request from Kruczek's has not been received. The one-year warranty for the Pearl Street project will not begin until the final payment has been issued. Tammy will ask Don Neitzel to meet with David Koch to go over his landscaping concerns.

Discussion was had on repairing Jackson Street. Concrete and mill/overlay estimates were presented to the Board for review. Tammy spoke with Jonathan from Ehlers to run different funding options. The Streets & Alley's committee should meet with Jonathan to discuss options for funding. The Dodge County Highway Department made recommendations for the road and culvert repairs needed.

Police Chief Bahr reviewed the monthly police report. Hours worked and calls for service for the month. There was nothing further.

Fire Chief Abell gave the fire department report. The merger is moving forward and the next meeting is on November 1<sup>st</sup>. There were four calls for service last month, including a structure fire, motor vehicle accident, mutual aid to Watertown and mutual aid to Waterloo.

Chief Abell also gave a brief update on the First Responders. They will start covering portions of Portland and Elba that are already covered by the Fire Department. It is likely that both will continue with EMR services in 2022.

The Protection of Persons, Property and Safety Committee have met several times to discuss the potential of having Dodge County police services in lieu of a local police department. A draft agreement for Dodge County police services was reviewed by the Board. The costs came in under the current police budget. There was a motion by David Snow and seconded by Chris Abell to approve the draft agreement for 2022 & 2023, contingent on approval by the Village's and County's legal counsel. Motion carried.

The 2022 Joint 911 Powers Agreement was reviewed by the Board and approved on a motion by Chris Abell and seconded by David Snow. Moton Carried.

There was no Residence Board Reports or Updates.

Library Director Kay Kromm gave the library report. Kay opened up the discussion for any questions. Questions included the number of borrows for the month, 46 cards were used. There were 267 physical visits and the total number of patrons (418) were both in person and online visits. An info graphic for 2020 data was also provided to the Board for review. In 2020, total circulation was 5,784. There were 540 cardholders, of which 51% are village residents. After school, kids made up 32% of the patron visits. There were no further questions or discussion.

Dean Ziegel gave an update on the utilities. The lift stations had their annual cleaning and the sewer line from North Main to Specialty Cheese was also cleaned. Well 1 is still down while repairs are being done to the pump. Five hydrants were prepped for refabrication. During the refabrication the first hydrant broke, as did the second one. A decision was made to stop and to not attempt any more hydrants. Dean has some calls in for replacing the broken hydrants.

Dean also gave an update on the streets. Dean spoke with Don Neitzel about our options with Jackson Street, which was also discussed during the engineer's report. Leaf pickup will begin soon and will be done two times per week on Mondays and Thursdays. Both leaves and brush pickup stop prior to Thanksgiving.

Ordinance A-134 "An Ordinance creating Sec. 11-2-15 "Prohibiting Motor Vehicle Compression Brakes" of the Municipal Code" was presented to the Board. There was a motion by Jim Bublitz and seconded by Chris Abell to adopt ordinance A-134. Motion carried.

Ordinance A-134 "An Ordinance Amending Sec. 10-1-12 "Speed Limits" of the Municipal Code" was presented to the Board. The 35 mph speed limits signs on North Main and Prairie Street will be moved to the Village limits from their current locations. There was a motion by Chris Abell and seconded by Jim Bublitz to adopt ordinance A-134. Motion carried.

The Board took a brief break from 8:55 p.m. to 9:05 p.m.

The 2022-2024 contract for assessor services with Grota Appraisals was reviewed by the Board and approved on a motion by Jim Bublitz and seconded by David Snow. Motion carried.

A new operator's license application for Rebecca Carey was approved on a motion by Jim Bublitz and seconded by Cheryl Goodrich. Motion carried. The license is valid through June 30, 2022.

Discussion was had on current Newsletter Ad fees. Kay Kromm, newsletter editor, explained that the sale of ads has been down. It is unclear whether the ad fees are too high or if the newsletter is not considered a relevant source of advertising anymore. The Board advised Kay to reduce the ad fees by 30% for the full- and half-page ads and to keep the quarter page and business card ad fees the same.

A "Compliance Assurance Plan" for the Village's recycling program was approved on a motion by David Snow and seconded by Jim Bublitz. Motion carried.

Ordinance A-136 "An Ordinance Amending Sec. 6-3-2 "Driveway and Culvert Location, Design and Construction Requirements" of the Municipal Code" was presented to the Board. There was a motion by Chris Abell and seconded by Grant Rushing to adopt ordinance A-136. Motion carried.

Brief discussion was had on property maintenance issues. Chief Bahr was advised to start issuing citations for properties that have been contacted previously and have not complied.

Dean Ziegel has contacted companies for estimates on gutters and ice spikes for the DPW building and the Police/First Responder building. Estimates are not yet available.

A dumpster has been rented and the DPW garage will be cleaned out and any scrap metal will be donated to the Lowell Fire Department for recycling.

The Community Center Board is meeting on November  $4^{th}$ , there was nothing new to report.

There has been interest from a couple of people about starting the recreation department back up. Debby Casperson was directed to reach out to those interested parties.

Village President, Brian Miller, made a recommendation to appoint Nancy Buss to the Community Center Board for a two-year term. There was a motion by Jim Bublitz and seconded by Cheryl Goodrich to approve the appointment. Motion carried.

The board discussed future agenda items.
