

Burn Pile


The burn pile is for brush and branches ONLY, no other items may be left there.

The freewill offering will be given to the Reeseville Library Children's Programs.


A holiday reception will be hosted in Fellowship Hall following the program.





PROCEEDINGS OF THE VILLAGE BOARD OF THE VILLAGE OF REESEVILLE November 11, 2021

A duly convened meeting of the Village Board of the Village of Reeseville, Dodge County, Wisconsin, was held in open session on November 11, 2021 and called to order by Village President, Brian Miller, at 6:30 p.m. The pledge of allegiance was recited. Roll call was taken and the following Trustees were present, Chris Abell, Jim Bublitz, Debby Casperson, Cheryl Goodrich, Grant Rushing and Dave Snow.

Notice of this meeting was given to the public at least 48 hours prior to the meeting by posting the complete agenda at the Reeseville Village Hall, the Reeseville Post Office, and on the Village's official website.

There were no public comments or input.

There was a motion by Jim Bublitz and seconded by Cheryl Goodrich to approve the consent agenda items, which include the minutes from the previous regular meeting, minutes from the special meeting, the Village Treasurer's report and Utility Treasurer's report. Motion carried.

There was a motion by Debby Casperson and seconded by Chris Abell to approve the Conditional Use Residential Planned Unit Development (PUD) on vacant parcel 177-1014-2812-003. Motion carried. The Housing Authority of Dodge, Wisconsin filed a petition for approval and the hearing took place at 6:00 p.m. before the Village Board. There were no public comments or objections at the hearing.

Tammy Hampton from Kunkel Engineering was present for the engineer's report. The final pay request from Kruczek's was presented to the Board for approval for \$29,502.93. The total project came in under the original contract by \$90,132.50. There was a motion by Jim Bublitz and seconded by Debby Casperson to approve the final pay request in the amount of \$29,502.93. Motion Carried. The one-year warranty for the Pearl Street project will begin on the date the final payment is made. Don Neitzel will be meeting with David Koch to go over his landscaping concerns.

Discussion was had on repairing Jackson Street. An updated cost estimate for mill/overlay and culvert repairs was presented to the Board for review. The total estimate came in at \$449,604. Tammy will be filing a application for LRIP and the awards will announced in February 2022. With the revised cost estimate, Tammy will reach out to Ehler's again to analyze the TIF and find out our options both with and without the possible LRIP funds.

Police Chief Bahr was absent and there were no police report available.

The Board reviewed the changes the Village Attorney recommended on the Dodge Count Police Service Agreement. There was a motion by Debby Casperson and seconded by Chris Abell to approve the attorney's revisions. Motion carried.

Fire Chief Abell gave the fire department report. There was one call for service last month, a motor vehicle accident. The CLR Fire Commission recently met and appointed Eric Howlett as the Chief for the new CLR Fire & Rescue Department, effective January 1, 2022.

Chief Abell also gave a brief update on the First Responders. The First Responders met and everything is in order for them to merge with the fire department.

The draft CLR Fire & Rescue Group Agreement was reviewed by the Board. There was a motion by Jim Bublitz and seconded by Debby Casperson to approve the draft agreement. Motion carried.

There was no Residence Board Reports or Updates.

Library Director Kay Kromm was absent. The library report was reviewed by the Board. Brian Miller read an email from Kay that gave an update on the new library digital sign. There is an issue with the software and the timer does not work. Kay thanked Jim Bublitz and Debby Casperson for turning the library sign on and off every day. It was also noted that Debby trimmed up the bushes around the library. There were no further questions or discussion.

Dean Ziegel gave an update on the utilities. Well number one is still down. The well is running, but not pumping at full capacity and needs to be fixed. The company has been working to figure out what's wrong and to find a solution. The hydrant modifications did not go as planned. Dave Snow returned the parts to Ferguson and they agreed to take back the parts and only charge a restocking fee.

Dean also gave an update on the streets. Leaf and brush collection will continue through November 18th, weather permitting. The County fixed pot holes on Jackson St., at the Village's expense.

Ordinance A-137 "An Ordinance Amending Sec. 10-1-27 "Snow Season Parking" and Creating Sec. 10-1-36 "Parking of Vehicles on Residential-Use Properties" of the Municipal Code" was presented for approval. There was a motion by Chris Abell and seconded by Dave Snow to adopt Ordinance A-137. Motion carried.

The Board reviewed a resignation letter from Police Chief Scott Bahr, effective November 16, 2021. There was a motion by Jim Bublitz and seconded by Cheryl Goodrich to accept Chief Bahr's resignation. Motion carried.

Ordinance A-138 "An Ordinance Appropriating the Necessary Funds for the Governing and Administration of the Village of Reeseville for the Year 2022 and the taxes levied" was presented to the Board for approval. There was a budget hearing at 6:15 p.m. before the regular meeting and there were no objections. There was a motion by Jim Bublitz and seconded by Debby Casperson to adopt Ordinance A-138. Motion carried.

The Board reviewed the 2022 Dodge County Humane Society Contract renewal. There was a motion by Jim Bublitz and seconded by Dave Snow to approve the contract for \$1,300 covering up to five animals. Motion carried.

There was nothing to report from the Public Health & Welfare Committee. The building permit log was reviewed.

A report was given for the Public Propety Committee. The 4-H donated an Auburn Maple tree for the Firemen's Park and has been planted near the playground. Debby Casperson noted that the trees in the park need to be professionally trimmed. Gary and Dan Kohn recently cut down two dead Ash trees in the park.

The Community Center Board recently met. The kitchen window has been fixed and a few reservations have been booked. A few Board members requested a report from the Community Center with reservations booked, to be reviewed at the monthly Board meetings. There was nothing further.

There was nothing to report from the Recreation Department.

The Community Center Board appointment was tabled.

The board discussed future agenda items.
