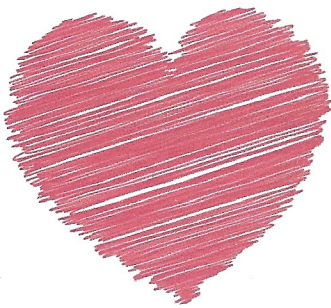

There will be no more fear. Mic 4:4

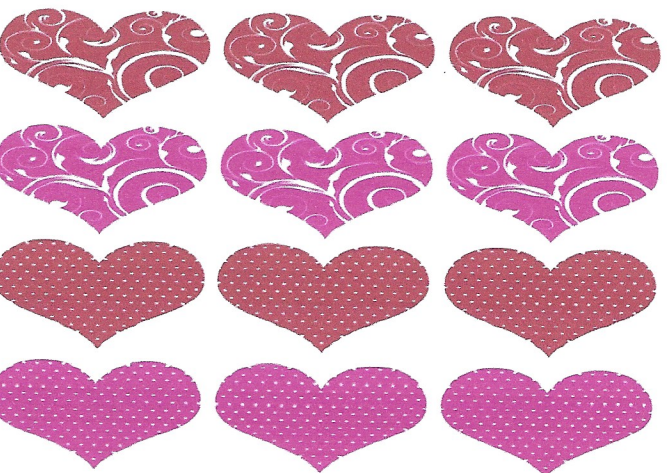

**PROCEEDINGS OF THE VILLAGE BOARD  
OF THE VILLAGE OF REESEVILLE  
January 13, 2022**

A duly convened meeting of the Village Board of the Village of Reeseville, Dodge County, Wisconsin, was held in open session on January 13, 2022 and called to order by Village President, Brian Miller, at 6:30 p.m. The pledge of allegiance was recited. Roll call was taken and the following Trustees were present, Chris Abell, Jim Bublitz, Cheryl Goodrich, Debby Casperson, Grant Rushing and Dave Snow.

Notice of this meeting was given to the public at least 48 hours prior to the meeting by posting the complete agenda at the Reeseville Village Hall, the Reeseville Post Office, and on the Village's official website.

Jeff Caine was present for public comment. Jeff passed out an ARPA funds overview provided by the US Department of the Treasury. The overview is informational only for the Board to review. Next Tuesday, the Board of Supervisors will begin phase two of the highway project and will be acting on road projects. Seventy-five percent of the membership "supermajority" will need to vote in favor of the projects to move forward. A list of the proposed projects was also passed out to the Board. There will be an informational meeting on January 24<sup>th</sup> at 2 p.m. and 6 p.m. regarding broadband funding and the need to expand in Dodge County. Dodge County is also accepting proposals from municipalities and non-profits for use of their ARPA funds. The proposal must be presented by a representative at their meeting on February 1<sup>st</sup>. The representative must have knowledge of the proposal/application and why the ARPA funds would benefit the applicant.

There was a motion by Cheryl Goodrich and seconded by Jim Bublitz to approve the consent agenda items, which include the minutes from the previous regular meeting, minutes from the special meeting on December 30, 2021, the Village Treasurer's report and Utility Treasurer's report. Motion carried.

There was no engineer's report.

Ordinance A-139 "An Ordinance Amending Section 5-2-10 "Lock Box Required" of the Code of Ordinances of the Village of Reeseville" was presented for approval. The amendment includes changes to incorporate and reference the fire department merger. There was a motion by Chris Abell and seconded by David Snow to adopt Ordinance A-139. Motion carried.

Ordinance A-140 "An Ordinance Amending Title 5, Chapter 1 "Law Enforcement" of the Code of ordinances of the Village of Reeseville" was presented for approval. The amendment includes changes to incorporate and reference contracting with the Dodge County Sheriff's Department. There was a motion by Chris Abell and seconded by Debby Casperson to adopt Ordinance A-140. Motion carried.

Ordinance A-141 "An Ordinance Amending Title 1, Chapter 2 "Use of Citation" of the Code of Ordinances of the Village of Reeseville" was presented for approval. The amendment includes changes to update the authorized officials to issue citations. There was a motion by Chris Abell and seconded by Debby Casperson to adopt Ordinance A-141. Motion carried.

Deputy Keberlein from the Dodge County Sheriff's Department was present to give the police report. Contracted services between the County and the Village started January 1, 2022. There have been seventeen events within the Village since the first of the year, nine of which have been traffic stops. Efforts have been made by officers on duty to stop in and meet with the public to introduce themselves.

Fire Chief Abell gave an update on the fire department. As of January 1, 2022 the fire department officially merged with Clyman and Lowell Fire Departments, known as CLR Fire & Rescue. The merger

has gained a lot of media attention and positive feedback. There has been one mutual call to Watertown and a few EMR calls. Things are going well and is a work in progress.

There was no Residence Board Reports or Updates.

Library Director Kay Kromm was absent. The library report was reviewed by the Board. There were no comments or questions. Jeff Caine noted that there are some on going problems with the sign. The company has gone out of business and there are is no customer services available. They will be checking with other sign companies to see if they can help looking at the programming.

There was nothing to report on the utilities, everything is going well.

Dean Ziegel gave a brief update on the streets. The streets are in good shape and Zechzers Excavating has been doing a great job clearing the streets.

There was a motion by Jim Bublitz and seconded by David Snow to have Ehlers's run a revenue loss calculation for ARPA. The calculation will cost approximately \$150 and is reimbursable with ARPA funds. Motion carried.

Estimates were reviewed for the well house generators. Action was tabled. The Board will submit a proposal to Dodge County with hopes to receive additional ARPA funds to be used towards generators. There was nothing further.

There was nothing to report from the Public Health & Welfare Committee. The updated ordinance book should be ready for approval at the February meeting.

There was nothing to report from the Public Property Committee.

Cheryl Goodrich gave an update on the Community Center. There was no meeting this month, due to lack of quorum. They will try to meet again in February. Denise Beal, Manager, created financials to compare 2019 vs 2020 revenue.

Ordinance A-141 "An Ordinance Amending Section 2-4-6 "Community Center Board" of the Code of Ordinances of the Village of Reeseville" was presented for approval. The amendment defines "outside rural Reeseville" as a radius of fifteen miles outside of the Village. There was a motion by Jim Bublitz and seconded by Debby Casperson to adopt Ordinance A-141. Motion carried.

There was nothing to report from the Recreation Department.

President Brian Miller made an appointment to the Community Center Board, naming Nancy Percifield for a two-year term. There was a motion by Cheryl Goodrich and seconded by David Snow to accept the appointment. Motion carried.

Christine Abell, Clerk-Treasurer gave an update on the nomination papers filed and the candidates running. Candidates include incumbents Chris Abell, Grant Rushing and Debby Casperson and new candidate Nancy Buss.

The board discussed future agenda items.
