

Winter Snow Regulations

Street parking is prohibited November 15-April 1, between 2am-6am. Tickets will be issued. Please also keep sidewalks clear of snow and salted. It is against village ordinance to purposefully dispense or move snow onto an adjoining property without the owners permission.

Burn Pile

The burn pile is for brush and branches ONLY, no other items may be left there.

VOTING BY ABSENTEE BALLOT Spring Election— April 5, 2022

Any qualified elector who is unable or unwilling to appear at the polling place on Election Day may submit a request to vote an absentee ballot to their municipal clerk. A qualified elector is any U.S. citizen, who will be 18 years of age or older on Election Day, who has resided in the ward or municipality where he or she wishes to vote for at least 28 consecutive days before the election. The elector must also be registered in order to receive an absentee ballot. Proof of identification must be provided before an absentee ballot may be issued.

You must make a request for an absentee ballot in writing or online at MyVote.wi.gov.

Contact your municipal clerk and request that an application for an absentee ballot be sent to you for the primary or election or both. You may also submit a written request in the form of a letter or you may apply for an absentee ballot online at MyVote.wi.gov. Your written request must list your voting address within the municipality where you wish to vote, the address where the absentee ballot should be sent, if different, and your signature. You may make application to your municipal clerk for an absentee ballot in person, by mail, by fax, by email or at MyVote.wi.gov.

Making application to receive an absentee ballot by mail The deadline for making application to receive an absentee ballot by mail is:

5 p.m. on March 31, 2022

Note: Special absentee voting application provisions apply to electors who are indefinitely confined to home or a care facility, in the military, hospitalized, or serving as a sequestered juror. If this applies to you, contact the municipal clerk regarding deadlines for requesting and submitting an absentee ballot.

Voting an absentee ballot in person

You may also request and vote an absentee ballot in the clerk's office or other specified location during the days and hours specified for casting an absentee ballot in person.

No in-person absentee voting may occur on the day before the election.

The municipal clerk will deliver voted ballots returned on or before Election Day to the proper polling place or counting location before the polls close on April 5, 2022. Any ballots received after the polls close will not be counted.

PROCEEDINGS OF THE VILLAGE BOARD OF THE VILLAGE OF REESEVILLE February 10, 2022

A duly convened meeting of the Village Board of the Village of Reeseville, Dodge County, Wisconsin, was held in open session on February 10, 2022 and called to order by Village President, Brian Miller, at 6:30 p.m. The pledge of allegiance was recited. Roll call was taken and the following Trustees were present, Chris Abell, Jim Bublitz (virtually), Cheryl Goodrich (virtually), Debby Casperson, Grant Rushing and Dave Snow.

Notice of this meeting was given to the public at least 48 hours prior to the meeting by posting the complete agenda at the Reeseville Village Hall, the Reeseville Post Office, and on the Village's official website. The agenda was also sent the Village's official newspaper, the Watertown Daily Times.

There were no public comments or input.

There was a motion by David Snow and seconded by Debby Casperson to approve the consent agenda items, which include the minutes from the previous regular meeting on January 13, 2022, minutes from the special meeting on January 12, 2022, the Village Treasurer's report and Utility Treasurer's report. Motion carried.

Don Neitzel and Tammy Hampton were present for the engineer's report. The Jackson Street project will be going out for bid on February 17th & 24th, with bid opening scheduled for March 4th. Discussion was had regarding the DOT BIL funding program and applying for funding for the Jackson Street project. Tammy did research on the program and the project would need to be ran like a DOT project which has stricter design requirements and the engineering expenses would not be reimbursable. Applying for the funding would also push back the project until 2023. The general board consensus was not to proceed with applying for the BIL funding and to move forward with the project for 2022. A public information meeting will be scheduled, prior to construction, to allow residents to ask questions or express concerns.

Sheriff Schmidt, Deputy Keberlein & Deputy Matoushek were present to give the police report. The Reeseville squad should be outfitted with the equipment upgrades soon and will be in service as soon as that's completed. Sheriff Schmidt spoke with a business regarding their noncompliance with the Knox Box ordinance. If the business does not come in to compliance, citations will be issued. The Board reviewed the monthly police report. The report(s) showed the hours worked for the month, the total number of incidents for the month and the nature of the calls for service. For the month of January, there were 51 incidents during the hours worked for the Village and over 80 incidents outside of dedicated hours served on behalf of the Village.

Deputy Fire Chief, Chris Abell, gave an update on the CLR Fire & Rescue Department. There were six fire calls and 16 first responder calls for the month. There are currently three members attending fire school.

The Board had a general consensus to jump to item 11; Finance & Personnel Committee Reports & Recommendations.

Resolution 2022-1 "Resolution Authorizing the Issuance and Sale of Up to \$304,683 Taxable Sewerage System Revenue Bonds, Series 2022, and Providing for Other Details and Covenants with Respect Thereto" was presented to the Board for adoption. There was a motion by David Snow and seconded by Debby Casperson to adopt Resolution 2022-1. A roll call vote was taken: Chris Abell -yes,

Jim Bublitz -yes, Debby Casperson -yes, Cheryl Goodrich -yes, Grant Rushing -yes, David Snow -yes and Brian Miller -yes. Motion carried (7-yes, 0-no).

There was a motion by Chris Abell and seconded by David Snow to approve the execution of the Financial Assistance Agreement for the Clean Water Fund Program. Motion carried.

Resolution 2022-2 "Resolution Authorizing the Increase in Wages for Water and Sewer General Laborers" was presented to the Board for adoption. The Resolution increases the water and sewer general laborers' wages to \$15 per hour. There was a motion by Grant Rushing and seconded by Cheryl Goodrich to adopt Resolution 2022-2. Motion carried.

The Board agreed to resume back to item 8 on the agenda; Library Reports and Updates.

The Board reviewed the library report. Joshua Brumm has been working on the sign software and has been making progress. The sign is on 24-hours a day and no longer shuts off at night. The Board asked about having the sign turn off at night so it doesn't become a nuisance to the neighbors.

Dean Ziegel gave an update on the utilities. The utilities are in good shape. A house flooded on Garfield due to frozen pipes. The basement was pumped out and the water was shut off.

Dean also gave an update on the streets. There has been little snow fall so the streets and the sidewalks have been in good shape. There are a few sports on Emerald where the asphalt is separating from the curb, which will be addressed with Kunkel in the spring.

Ordinance A-143 "An Ordinance Adopting a Revision and Codification of the Ordinances of the Village of Reeseville, Wisconsin" was presented for adoption. There was a motion by Debby Casperson and seconded by Chris Abell to adopt Ordinance A-143. Motion carried.

Ordinance A-144 "Amending Chapter 138 "Records, Public" of the Code of Ordinances of the Village of Reeseville to Add a Section Providing for a Fee Schedule" was presented for adoption. There was a motion by Chris Abell and seconded by Grant Rushing to adopt Ordinance A-144. Motion carried.

Resolution 2022-3 "Resolution Adopting Village Fee Schedule" was presented for adoption. There was motion by Cheryl Goodrich and seconded by Jim Bublitz to adopt Resolution 2022-3. Motion carried.

Ordinance A-145 "An Ordinance Amending Chapter 12, Section 10 "Salaries" of the Code of Ordinances of the Village of Reeseville" was presented for adoption. The ordinance increases the wages for the board trustees and the president. The wages take effect starting with the new term for each official. This would be the first wage increase for the Board since 1999. There was a motion by David Snow and seconded by Debby Casperson to adopt Ordinance A-145. Motion carried.

David Snow gave an update on some garbage complaints that have been taken care of. A committee meeting will be scheduled at a later date to meet with Deputies Keberlein & Matoushek regarding property maintenance issues and junk vehicles. There was nothing further.

There was nothing to report from the Public Property Committee.

There was nothing new to report from the Community Center Board. Their next meeting will be held in March.

There was nothing to report on the Recreation Department. The board discussed future agenda items.
