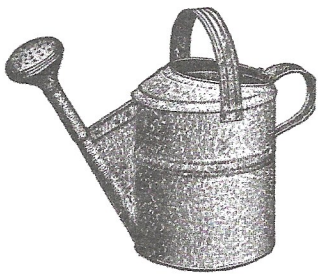

The burn pile is for brush and branches **ONLY**, no other items may be left there.

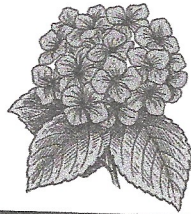
### Trash Collection

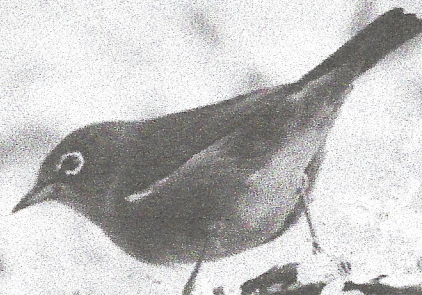

### AARP WI 'Small Dollar, Big Impact' grant

A proposal submitted by the Reeseville Public Library to purchase materials that will be packed into nearly a dozen "Naturalist To Go Kits" for families to check out from the library and utilize in various nature/science settings has been selected to receive this month's AARP Wisconsin "Small Dollar, Big Impact" grant.

AARP Wisconsin is awarding grants each month throughout 2022 to projects across the state that are designed to improve communities and make them better places for everyone to live, work and play as they age. Judges selected this project for a \$1,000 grant after reviewing dozens of proposals submitted from all over the state.

"These grants are exactly what the name describes – short-term, low-cost solutions that could have remarkable impacts on the shaping of neighborhoods and cities," said Darrin Wasniewski, Associate State Director of Community Outreach for AARP Wisconsin. "Reeseville Public Library's Naturalist To Go program embodies the spirit of Small Dollar, Big Impact Grant. The library identified a community strength and developed a way to enhance it so that it can be easily scaled up from this beginning stage. These kits provide an excellent opportunity to experience nature."

The library is in the process of gathering supplies to create 10 Naturalist To Go Kits, which will center around the themes of insects, rocks, astronomy, trees and weather. *Each kit will include books, a clipboard, a pack of colored pencils, a No. 2 pencil, a nature journal with blank paper, coloring pages, and items specific to the science such as a set of junior binoculars, compass, plastic ruler or magnifying glass.*

The items will all be packed into canvas backpacks, which will be available for checkout at the library. Families can come in and pick out a theme to learn more about, then take the kit out into nature for their own adventure.

"The Reeseville Public Library is grateful to AARP for awarding us the Small Dollar, Big Impact Grant to fund our Naturalist To Go Kits," said library director Kay Kromm. "We are excited to be able to promote an intergenerational love of natural science. This grant is an excellent fit for the library will make a great impact on our small community."

The project was launched after the Reeseville Library Board and the Friends of the Library brainstorming ways that the library can better serve the community in a digital world. One of the ideas that had been discussed for years is that of naturalist To Go Kits.

"Reeseville is a village with just under 700 individuals. The library is the only safe and free place for folks to find education and entertainment. Internet access is also an issue in our rural community. We strive to engage patrons of all ages from a small library in an old, converted house," Kromm said. The kits will allow families to learn about nature on their own schedule with as many individuals as they choose. The kits, which can be obtained and used by anyone with a library card, will give library patrons all the items they need to explore natural science together on their own schedule.

AARP Wisconsin's launched its "Small Dollar, Big Impact" grant program in 2020 and is now in its third year of helping proposed projects move forward in rural and urban parts of the state.

"This project fits perfectly with the spirit and intent of the Small Dollar, Big Impact grant program," said AARP Wisconsin Interim State Director Christina FitzPatrick. "Our goal is to support communities as they make positive changes that inspire long-term progress on livable issues. This proposal hits that nail right on the head."

## The Refuge of Reeseville Church May 2022 / The Last Days

Greetings from the Refuge Church.

As we see our society's norms change right before our eyes, and we seem to be experiencing a quickening in the passage of time, we at the Refuge thought it would be wise to initiate an awareness of "Biblical End Times."

**[ The following is what the Refuge believes and preaches and is paid for by the Refuge Church.]**

Many of us believe we are in the last days. Many of us also believe Jesus Christ will return and set up His Kingdom, where He will rule over the inhabitants of the earth.

But, how do we know this? What are some specific things, or current events, that we can point to, proving at least to ourselves, that Bible Prophecy is alive in our lifetime? Our number one goal is to "Not be Deceived."

Jesus has warned us to not be deceived, for many surely will be; and perhaps, most likely it will be the ones who thought that they would not be. Mark 13:5&6 / Matt 24:5,24 / Luke 21:8 / Rev 19:20

So, with that, we are not here to argue, nor debate. We are here to learn and get a better understanding of what the Bible does say, so we will not be deceived. There will be no need to offend anyone, nor a reason to argue, for one day, we will all find out the Truth.

It would be foolish for us to think that we can figure out exactly how the "End Times" are going to go down. Who would have thought or imagined that our worldwide response to Covid would appear to be so paralleled with some of the events for told in the Bible concerning the End Times ?

So, for us, the most important thing to do is be as knowledgeable as we can of exactly what the Bible says. Then perhaps, we can share it with our loved ones, friends and anyone else who will listen.

What we will share with you today is, we believe, arguably, the most logical order of end time events, revealed to us in the Bible.

We also believe many of the traditional theories about the End Times that we, as a society, hold to today, such as: "7 years of tribulation", "pretribulation rapture", "the church will not see tribulation", "the holy spirit needing to be taken out of the way before the antichrist can be re-

Perhaps a large contributor to this was the lack of technology. Bible readers of the past were unable to perform large cross references of the entire Bible, nor make computerized lists and organizations of scripture. Not without tedious and obvious time consuming work of laying out dozens and dozens of scripture, from all through-out the Bible. If you could read that is, and if you had a Bible, then perhaps.

Maybe you would be able to discern the Truth, if you were a genuine seeker of Truth with an analytical and logically working mind, and able to separate yourself from the popular culture of the time. Such as a Newton, Luther, Socrates, or a Servetus.

But, today we have the ability to search as many end time related scriptures as we can, all laid out before us, and have an understanding of the logical foundation of scripture, to ensure we will not be deceived.

The apostles had tremendous insight into the last days and the order of events. Ie. Paul, his commentary in Thessalonians; John, the author of Revelations. They may have had no idea when Jesus would return, but they sure knew what to watch for. They saw and learned amazing things, and wrote down enough information for us, so we also might not be deceived.

There is a myriad of places we could begin, so let us begin with this one defining point. We are told in the Gospel of Matthew 24, about a time when the disciples are showing Jesus how wonderful the Temple in Jerusalem is. Jesus responds by telling them that this Temple will one day be destroyed. Perhaps the disciples were shocked by this information.

Then they proceed to ask Him, "when will this happen? and what is the sign when this will all occur?" Jesus answers by telling them exactly what to watch for. He makes a statement that should stick out.

"when you see..."

Let that phrase stick in your mind. "When you see." Because there are things we are going see, thus the reason why we are having our End Times seminar.

**PROCEEDINGS OF THE VILLAGE BOARD  
OF THE VILLAGE OF REESEVILLE  
April 14, 2022**

A duly convened meeting of the Village Board of the Village of Reeseville, Dodge County, Wisconsin, was held in open session on April 14, 2022 and called to order by Village President, Brian Miller, at 6:36 p.m. The pledge of allegiance was recited. Roll call was taken and the following Trustees were present, Chris Abell, Jim Bublitz, Debby Casperson, Cheryl Goodrich, Grant Rushing and Dave Snow.

Notice of this meeting was given to the public at least 48 hours prior to the meeting by posting the complete agenda at the Reeseville Village Hall, the Reeseville Post Office, and on the Village's official website.

There were no public comments or input.

There was a motion by Jim Bublitz and seconded by Debby Casperson to approve the consent agenda items, which include the minutes from the previous regular meeting on March 10, 2022, the Village Treasurer's report and Utility Treasurer's report. Motion carried.

Tammy Hampton from Kunkel Engineering was present for the engineer's report. Tammy gave an update on the Jackson Street project's LRIP funding. The Village was awarded an LRIP grant match up to \$400,000. The project will go out for bid over the next week and bids will be opened on April 22<sup>nd</sup>. The Village will have to front the full cost of the project and will then be reimbursed by the DOT after completion of the project. The Village will need interim financing. A special meeting was scheduled for April 27<sup>th</sup> to review the bids and award the bid for the project.

Deputy Keberlein was present to give the police report. The hours worked and calls for service, both contracted and noncontracted, were reviewed by the board. The squad car is still waiting on parts before it can go into service. A noncompliance dog license letter has been drafted and will be sent to residents with unlicensed dogs. Residents will have until May 31<sup>st</sup> to license their dogs or citations will be issued.

CLR Deputy Chief Abell gave an update on the fire department. There were five fire calls for the month, and fourteen First Responder calls. In the first quarter of the year, there have been fifty EMS and twenty-four fire calls, district wide. If the trend continues, they may see a total of 300 calls for the year. There recently was a new member interview and three members are still in school. CLR applied for ARPA funding from Dodge County and are hopeful for funds to create EMS quarters for future EMS services out of one of the existing stations.

Discussion was had on placement of a scrap metal trailer. The CLR would have a trailer in Reeseville for residents to leave scrap metal. The metal would then be recycled and the money would be used as fundraising for the department. The Board agreed to house the trailer by the Harrison Street lift station, behind the fence, to keep it secure and safe. That way they can also monitor what is put in the trailer.

There was nothing to report from the Residence Board.

The Board reviewed the library report. There were no comments or questions.

Dean Ziegel gave an update on the utilities. Everything has been running well. Dean discussed a generator quote for well #2. Total Energy Systems/Buss Electric came in at \$52,000. Discussion was tabled.

Dean also gave an update on the streets. Street cleaning is scheduled for April 26<sup>th</sup>. Dean has made calls for asphalt to fill pot holes. Asphalt won't be available until May 1<sup>st</sup>. There will be curb work and storm sewer repairs. A quote from Rennhack's for \$4,110 was presented to the Board to repair the sidewalk on North Main Street by Fireman's Park. The Board had already budgeted \$5,000 in the current year's budget to have those repairs done. Dean was instructed to move forward with the repairs.

Jim Bublitz gave an update on the ARPA funds. Applications have been sent to Dodge County for allocations of their ARPA funds to be used for generators at both well houses, generators at the DPW office and the Village Hall, a new chlorination building at the sewer plant and for water hydrant replacements. The County is still reviewing applications at this time and there are no updates at this time.

Dave Snow stated there were no issues with garbage collection this month. The Public Health & Welfare Committee in conjunction with the Protection of Persons, Property & Safety Committee scheduled a meeting for April 28<sup>th</sup> at 4:30 p.m. to meet with the Deputies to review property maintenance issues and junk vehicle concerns.

Dean Ziegel gave a quote on the Village Hall repairs needed. A quote from HH Improvements was obtained for soffit, and gutters. The quote came in at \$7,043. The Board had also previously budgeted funds for these repairs. There was a motion by Debby Casperson and seconded by Chris Abell to approve the quote and to make a 50% down payment. Motion carried.

Discussion was had on the current mowing contract and the issues from last season. Dean called the vendor and told them about the Village's concerns. The vendor has promised to do better. There was no further discussion.

Cheryl Goodrich gave an update on the Community Center. The March check register and scheduled reservations were reviewed by the Board. There was nothing further.

Debby Casperson gave an update on the Recreation Department. T-ball will begin for 3-5-year-olds and will meet on Tuesday evenings at the baseball diamond. So far there are six interested families. They do not need lights and there's already a port a potty on site for public use. The Board agreed to allow the group to use any T-ball equipment on site as long as it's returned in its original condition. There was nothing further.

The Clerk-Treasurer, Christine Abell, gave an update on the 2022 Spring Election results. Incumbents Chris Abell, Grant Rushing and Debby Casperson were reelected as Trustees for another two-year term.

The board discussed future agenda items.
