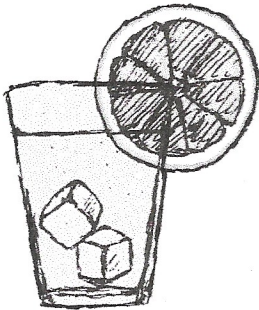

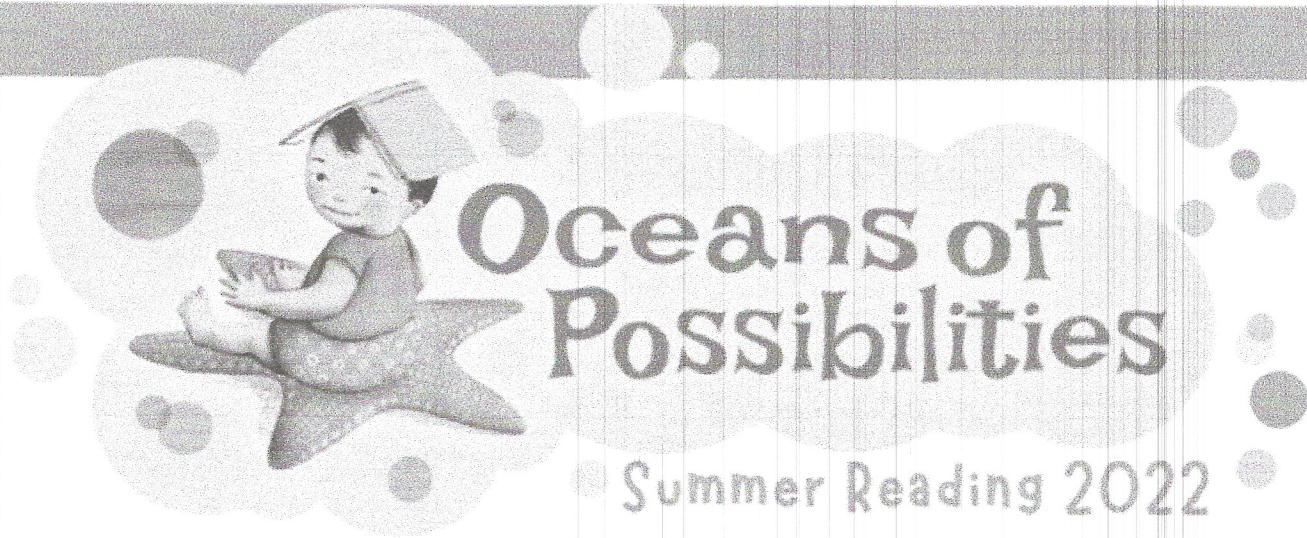

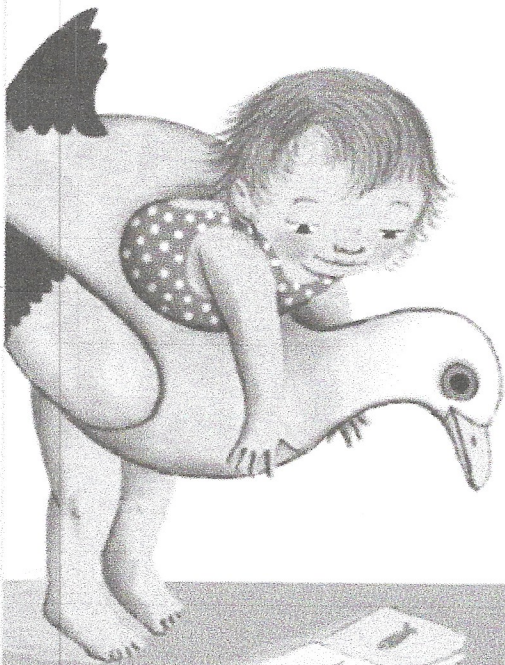

Senior Farmers' Market Vouchers for Dodge County - 2022

The Senior Farmers' Market Nutrition Program (SFMNP) provides eligible seniors with vouchers to use at area farmers' markets and participating roadside stands to help stretch their food dollars.

You must be 60 years of age or older (or a Native American 55 or older) and reside in **Dodge County**. Household income must be at or below 185% of federal poverty level:

- o 1 person: \$2,096 monthly / \$25,142 annual income
 - o 2 persons: \$2,823 monthly / \$33,874 annual income
 - o 3 persons: \$3,551 monthly / \$42,606 annual income
 - o 4 persons: \$4,279 monthly / \$51,338 annual income
 - o For each additional household member, add \$728 monthly / \$8,732 annually
- Each eligible household will receive \$25 in vouchers to use at authorized farmer's markets to purchase only Wisconsin grown fruits, vegetables, and herbs.

Vouchers will be distributed on a **"first-come, first-serve" basis by calling 920-386-4338 and completing an eligibility screening over the phone.** Eligible applicants will receive their vouchers via mail beginning July 1, 2022. Vouchers must be used by October 31, 2022.

Blessing from the Refuge Church.

The prophet Jeremiah, of the Old Testament, is quoted in Jer 20:9 as saying, The Word of God was in my heart like a burning fire! It feels like it is burning deep in my bones! I get tired of trying to hold it in, indeed, I cannot. And then, in chapter 24 of the Gospel of Luke, two of Jesus' followers who were being taught about the bible by the resurrected Jesus Himself, had this to say about how they felt after Jesus had taught them.

Luke 24:32 And they said one to another, Did not our heart burn within us, while He [Jesus] talked with us and opened to us the meaning of the bible?

[The following is what the Refuge believes and preaches and is paid for by the Refuge Church.]

Jeremiah 23:29 also records a rhetorical question from the Lord Jesus, as in one where the answer is an obvious yes! Are not My Words like a Fire?

What does this mean? The Word of the Lord in our hearts like a fire? Have you ever felt that in your heart? Like Jeremiah or the two disciples of the Lord Jesus? It seems to me, that from these two accounts, this experience of the Word of the Lord being as a Fire inside of us, will only happen when we have a desire for His Righteousness. For they are one and the same.

Psa 33:4 For the word of the LORD is right; and all his works are done in truth.

Nature itself teaches us that fire has a cleansing effect. Many of nature's environments benefit from occasional fires, because they tend clean out the dead plant and animal material laying around. And some plant and animal life even require the effects that fire will bring in order for them to survive and flourish. Yes, fire is can be very destructive, but also very necessary for a healthy environment.

So, it is with our own hearts. We tend to fill it up with garbage from the TV. We tend to hold on to dead things, like unforgiveness and anger. And then we contaminate our hearts with pride and arrogance that can really stink up a home and a society. Then, to top is all off, we justify all that garbage in our hearts with our own self-righteousness. All of which may hinder the blessings of God in our lives.

And if there is one thing that I know, I desire the blessings of God in my life and especially in the lives of my family.

See, in the Bible, the Fire represents and is symbolic of God Himself. His Presence & His Word, for God is an consuming Fire.

Deuteronomy 4:24 For the LORD thy God is a con-

suming fire.

Hebrews 12:29 For our God is a consuming fire.

Jeremiah and the two disciples of Jesus had this Fire inside of their hearts. And we can only imagine the Eternal Glory that has been awaiting them. Look, we know that we feel like we need to trust in the world. We feel like that's the only way to survive. This is even what we sometime desire more than anything else. Because, we've been taught all our lives it really doesn't matter. It doesn't matter what we believe. "To each his own," right? It doesn't matter if we hurt or abuse others, right?

So please be mindful of ordinance Sec. 6-2-11 Unlawful Dumping on Streets "It shall be unlawful for any person to deposit or cause to be deposited, dump, sort, scatter or leave any rubbish, stone, wire, earth, ashes, cinders, sawdust, hay, glass, manure, filth, paper, snow, ice, dirt, grass, leaves, construction waste, garbage or other offensive or noxious material in any public street, sidewalk, alley or upon any public property or upon any property of another, without the express permission of the owner of occupant thereof."

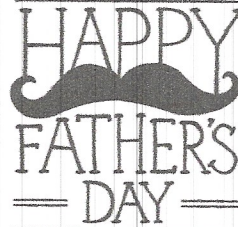

**PROCEEDINGS OF THE VILLAGE BOARD
OF THE VILLAGE OF REESEVILLE
May 12, 2022**

A duly convened meeting of the Village Board of the Village of Reeseville, Dodge County, Wisconsin, was held in open session on May 12, 2022 and called to order by Village President, Brian Miller, at 6:33 p.m. The pledge of allegiance was recited. Roll call was taken and the following Trustees were present, Chris Abell, Jim Bublitz, Debby Casperson, Cheryl Goodrich, Grant Rushing and Dave Snow.

Notice of this meeting was given to the public at least 48 hours prior to the meeting by posting the complete agenda at the Reeseville Village Hall, the Reeseville Post Office, and on the Village's official website.

David Brown was present for public comment. David wanted to state his support and commend the Dodge County Sheriff's Department for their presence and work in the Village.

Tami Delisle was present for public comment. Tami wanted clarification on the new ordinance regarding parking on improved surfaces. The Board clarified that an improved surface could be a gravel pad, concrete, blacktop or cement. A permit will be required for changes to driveways. Tami also wanted to discuss the feral cat problems in the Village. The "Spay Me!" clinic in Madison will do low cost spay and neuter for community cats. The cats would be spayed or neutered and then must be returned to the area they were originally captured from. The cat's ear would be notched to signal that cat has already been fixed. Tami volunteered to help drive the cats to/from the clinic and to trap and release. It was suggested to see if there would be any other residents willing to volunteer their time.

Trisha Caine was present for public comment. T-ball is starting in the summer and so far, thirteen families with 3-6-year olds have signed up. The program is all for fun. The Board will allow the group to use all of the equipment as long as it's returned in its original condition. It was suggested that the former Baseball Association be contacted to see if there are any left-over funds that can be used for specifically for T-ball equipment. The program will start June 7th and continue on Tuesday nights. The Village will continue to keep up the field maintenance and the bathrooms will be de-winterized.

Kyle Gibson was present for public comment. Kyle discussed his concerns with Willow Court needing to have the final street layer paved and finished. The potholes and deterioration are making it difficult for homeowners and families to use the street safely. Other property owners on Willow Court were also present to show their concern. It was suggested that with the Jackson Street project being partly funded with a grant that the Village consider finishing Willow Court with the cost savings from that project.

There was a motion by Jim Bublitz and seconded by Cheryl Goodrich to approve the consent agenda items, which include the minutes from the previous regular meeting on April 14, 2022, the special meeting minutes from April 27, 2022, the Village Treasurer's report and Utility Treasurer's report. Motion carried.

There was no engineer's report or update.

Deputy Keberlein was present to give the police report. The hours worked and calls for service, both contracted and noncontracted, were reviewed by the board. The squad car is still waiting on parts before it can go into service. The department is working with the Public Health & Welfare Committee on property maintenance issues. Letters will be sent out to property owners in violation of village ordinance.

Deputy Keberlein asked the Board for their input on “National Night Out”. “National Night Out” is on August 2nd. A committee will meet to work out the details.

CLR Deputy Chief Abell gave an update on the fire department. Three members have finished class and two have moved on to the next level. There are two pending new member applications and one accepted new member. There was nothing further to report, the number of calls for service were not readily available.

Lifestar is in need of a storage location for their backup ambulance. The rig would need to be easily accessible. There was a motion by Debby Casperson and seconded by Jim Bublitz to allow Lifestar to store their ambulance with the Village. Compensation for storing the rig is to be determined at a later date. Motion carried.

There was nothing to report from the Residence Board.

The Board reviewed the Library Director’s report and the budget year to date. There were no comments or questions.

Dean Ziegel gave an update on the utilities. The 2021 Consumer confidence Report was tabled; the report is not yet ready. The Board reviewed the quote from Buss Electric for a generator at Well 2 for \$52,000. The quote has expired since it was produced. There was a motion by Jim Bublitz to approve the quote with a 10% contingency on price increase. Jim then amended his motion to include the generator will be funded by the use of ARPA funds. Debby Casperson seconded the motion and amendment. Motion carried. A quote for the chlorination building was reviewed by the Board. The replacement was estimated at \$25,575. There was a motion by David Snow and seconded by Jim Bublitz to approve the Sewer Chlorination Building. Motion carried. A quote from United Electric was also reviewed by the Board for a generator at the DPW office, located at 208 Firehouse Drive. The generator could then be connected to the emergency responder storage building/municipal offices at 214 Firehouse Drive. The quote only covered the cost and installation at the DPW office. There was a motion by Chris Abell and seconded by David Snow to approve the generator and connection to 214 Firehouse Drive, not to exceed \$15,000. Motion carried.

Dean also gave an update on the streets. The streets were cleaned last month and the potholes will be fixed soon.

There was nothing to report from the Finance & Personnel Committee.

Trustee David Snow gave an update on the Public Health & Welfare Committee. The committee met last month with the sheriff’s department to discuss property maintenance issues and junk vehicles. A letter will be sent out to properties in violation of village ordinance. The letter will outline the violation, the ordinance and the penalty/forfeiture. A second letter will be sent after the initial letter if the property isn’t brought into compliance. A third letter will be hand-delivered by a deputy if the property is still not in compliance.

The DNR received a complaint regarding the Village burning yard waste. The Village was notified that it is illegal for the Village to burn brush without proper licensing and we must follow the criteria involved in obtaining the license. The Board discussed possible alternatives, including getting a tree service to come on a regular basis to chip the brush and remove the chips. It was also suggested that the Village should use its own chipper and leave the chips for residents to use for mulch and landscaping needs. The Public Health & Welfare Committee scheduled a meeting for May 19th to discuss the burn pile and alternative yard waste collection avenues.

There was nothing to report from the Public Property Committee.

Trustee Cheryl Goodrich gave an update for the Community Center. The Community Center Board will be meeting in June. Reports with the reservations and checkbook register were reviewed by the Board.

There was nothing to report from the Recreation Department.

The Board acted on moving the June Board meeting date from Thursday, June 9th to Wednesday, June 8th on a motion by David Snow and seconded by Cheryl Goodrich. Motion carried.

President Brian Miller asked the Board to extend the current appointments and designations by one-month. There was a motion by David Snow and seconded by Jim Bublitz to approve the extension. Motion carried.

The board discussed future agenda items.
