**PROCEEDINGS OF THE VILLAGE BOARD
OF THE VILLAGE OF REESEVILLE
September 15, 2022**

A duly convened meeting of the Village Board of the Village of Reeseville, Dodge County, Wisconsin, was held in open session on September 15, 2022 and called to order by Village President, Brian Miller, at 6:30 p.m. The pledge of allegiance was recited. Roll call was taken and the following Trustees were present, Jim Bublitz, Debby Casperson, Cheryl Goodrich, Margaret Schmidt, and Dave Snow. There is one trustee vacancy.

Notice of this meeting was given to the public at least 48 hours prior to the meeting by posting the complete agenda at the Reeseville Village Hall, the Reeseville Post Office, and on the Village's official website.

Jeff Caine was present for public comment or input, and gave an update on the ARPA request. The committee approved the request by a simple majority however a super majority is required therefore the chloring building and fire hydrants project is tabled until October. Jeff Caine will continue to try and get the request to pass.

There was a motion by Cheryl Goodrich and seconded by Debby Casperson to correct the minutes as Margaret Schmidt was omitted from the roll call; and approve the consent agenda items which include the minutes from the previous regular meeting on August 11, 2022, the Village Treasurer's Report, and the Utility Treasurer's Report. Motion carried.

Engineers are starting to fix the culvert next Monday, Lalonde Contractors to set up and block off the culvert with equipment, and are scheduled to pour next Friday. Deputy McCarty parks at Main Street and Jackson Street stopping people as they still go over the culvert even though there is detour signage. Letters will be going out to residents tomorrow to notify them of the October 28, 2022 deadline to complete the work. They are behind due to having to fix the culvert.

There was a motion made by Dave Snow and second by Debby Casperson to proceed to pay request #1 to LaLonde Contractors in the amount of \$224,821.36. Motion carried.

Deputy McCarty was present to give the police report, the hours worked and the incidents for the month were reviewed. There we a total of 44 calls, most of which were building / area checks.

CLR Fire & Rescue has nothing to report. LifeStar EMS reports calls up more than usual. CAEMS reports Columbus, Reeseville, and Elba will need to increase the budget for next year. Discussion to use Law Enforcement Agency Grant of \$7,000.00 for the police car radio was approved.

There was no update from the Residence Board.

The board reviewed the library report and budget year-to-date.

Dean Ziegel gave an update on the utilities. There was a second pump put in on Prairie Street two weeks ago, we had 5 inches of rainfall last week and the pump held out fine but was at it's maximum. Tuesday, USDA was here to check the ponds and lift stations and took water samples from the same three places as last visit to send to the DNR. Flags were taken down today, they later due to leaving them up for the corn roast.

Discussion on the snow plowing contract for the 2022 – 2023 winter. Cheryl Goodrich motions and Jim Bublitz seconds the motion to hire Zechzer for the \$18,000.00 contract with negotiation to determine how much and when payments will be made. Motion carried.

Budget meet was set for October 20, 2022 at 6:30 pm, the entire board is invited. Jeff Caine already discussed the ARPA Grant. Discussion was had on the possible action of virtual meeting policy. If we do have virtual meetings, the meetings must be open virtually to the public and the audio / visual equipment will need to be updated, there is an initial quote of \$2,000.00 - \$3,000.00. Jim Bublitz will have a policy put together.

Public Health and Welfare Committee Repots & Recommendations: Residents have been putting a lot of couches out on the curb, as well as more than one large item. Badgerland has been taking just one large item from each house. Suggestion was made to put notice in the newsletter. The gate at the brush pile is broken again, perhaps look into getting a camera at the site? Discussion on continuing as is, as we are not getting anything big enough to chip.

Public Property Committee Reports & Recommendations: Debby Casperson discussed the commercial grade playground equipment, and found two playsets to choose from. The residents asked to make it more Autistic friendly, they do offer a full support swing that will be added to the swing frame. Discussion was had in regards to the cost of rubber tire mulch and edging along with landscaping, and budgeting some funds to fix the sidewalks at the park. The Board agreed on the covered playset, and the swing set to have 2 regular swings, 1 infant swing, and 1 special needs swing. Debby Casperson will get a price on removal and total installation.

Community Center Reports & Updates Cheryl Goodrich made a correction on the September 24, 2022 event from Reunion to Specialty Cheese picnic.

Recreation Departments Reports & Updates: Dean Ziegel reports that the generator was delivered to the shop. United Electric will wire and install a new electric panel and the generator.

The Board discussed future agenda items; policy on virtual meetings and ARPA.

Jim Bublitz motioned and Debby Casperson second the motion to hold Trick-or-Treating on Sunday. October 30, 2022 from 3:00 pm to 5:00 pm. Motion carried.
