*Larry Ludtke*

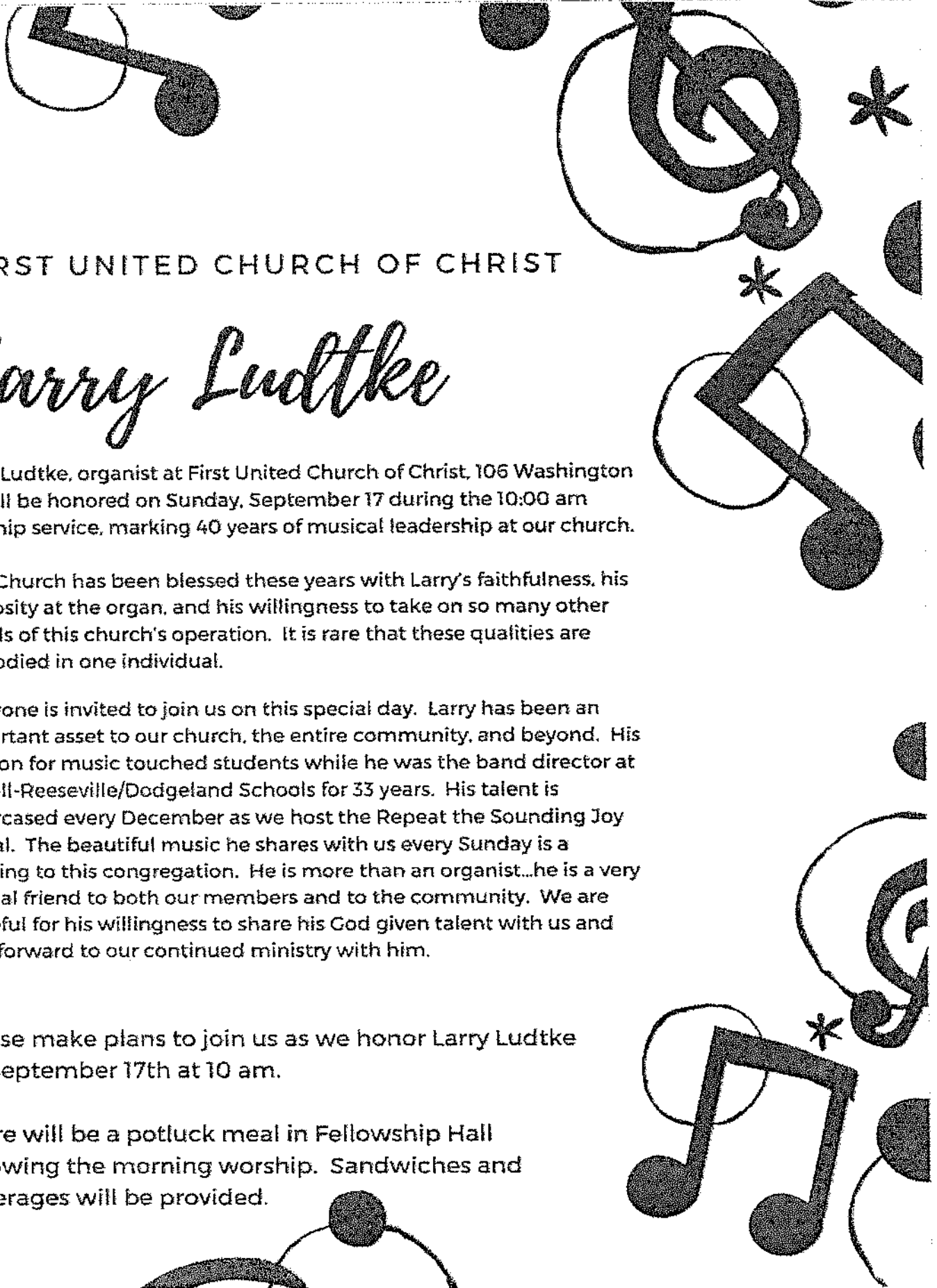

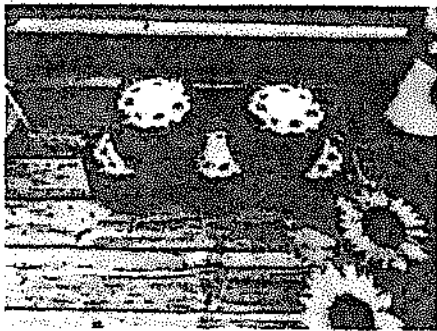

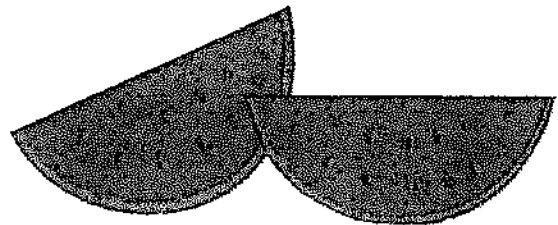

**PROCEEDINGS OF THE VILLAGE BOARD  
OF THE VILLAGE OF REESEVILLE**

**July 13, 2023**

A duly convened meeting of the Village Board of the Village of Reeseville, Dodge County, Wisconsin, was held in open session on July 13, 2023, and called to order by Village President, Brian Miller, at 6:33pm. The pledge of allegiance was recited. Roll call was taken, and the following Trustees were present, Anna Volkova, Dave Snow, Jim Bublitz, Jacob Pacala, Kevin Hankes. Absent Cheryl Goodrich.

Notice of the meeting was given to the public at least 48 hours prior to the meeting by posting the complete agenda at the Reeseville Village Hall, the Reeseville Post Office.

Jim Bublitz made a motion to approve the consent agenda with moving item 14d.up (Discuss and approve Farmers Market to potentially start up in the village) the motion was seconded by Jacob Pacala, and the motion carried.

Public comment: Greg Guetzloff addressed the board with concerns of grass not being cut in the village according to the village ordinance and asked the village board what was being done about? Greg Guetzloff addressed the village board about trees not being cleaned up that have fallen several months ago, and dog feces not being cleaned up when people walk their dogs. Matt Bonde was present for public comment and addressed the village board about his property at 500 South Main Street, and asked the village board about rezoning the property because he has a potential buyer. Matt Bonde said he is working on cleaning the property up. Brian Miller asked if all bills were current and Matt replied they were, Margaret Schmidt questioned the property taxes and gave Matt a copy of the tax bill, Matt was going to check with the county, Matt Bonde stated he had those paid in full. Brian Miller said the Chair of the Public Health and Welfare Committee can set up a meeting with Matt Bonde and the building inspector Rob Froh, and the committee members to discuss floor plans and to see if we can rezone the building and bring it to next month village board meeting.

Agenda item 14d. was moved up to public input, Leneva Earl was present and asked the village board to approve starting a farmers' market in the village. Leneva, stated Minn's General Store offered there parking lot for vendors to set up or would the board like it set up in the park? Brian Miller thought the park would be good, but if you want to hold it at Minn's, Brian is ok with that. The board discussed the farmers market and Dave Snow suggested that if you use the park coordinate with Denise Beal (manager of RCC), so there are no conflicts. Jim Bublitz said the pavilion is available and can be used as well. Kevin Hankes made a motion to approve the farmers market to be held in the tennis court area at the park, the motion was seconded by Jim Bublitz, and the motion carried.

Engineer report, Tammy Hampton was present, and handed out the map of the 10-year Capital Improvement program, Tammy reviewed the map with the village board. Tammy informed the board that DOT funding is available, and DOT will match 80/20 of the funding, applications are due 10/27/2023, and DOT will tell you when you can construct the project, DOT handles the bidding of the project, and DOT manages the project. Water and sewer not eligible with DOT project. Don Neitzel stated if we show the street by the businesses, it will help improve our case. Tammy and Don would be happy to meet with the committee to discuss this more, Jake Pacala will work on setting up a committee meeting. Tammy reported Tap awards is available, and Tammy will check on sidewalk funding with Taps.

Don Neitzel reported the chlorine building is sitting in Fon Du Lac, and they will be here next week to get started on it. Don reported the signs on Jackson Street are up and everything is good. Dave Snow stated the tree boarders need to be redone. Brian Miller stated the tree boarders need to be mowed or the village will have the boarders mowed and bill the property owner.

Protections Persons Property-Safety, Officer Nicholas reported the village had 46 calls of service, and hours worked were 48.5. The 46 calls for service consisted of building check, miscellaneous, family trouble, civil matter, traffic

stop, fireworks, Ems request and welfare check. Officer Nicholas will have Officer Keberlein check on the property on North Main Street which is a concern according to village ordinance.

CLR update, discussed getting a backup generator for village hall because of the storm outage and a resident with ALS, and when the power outages happen, a generator is taken to the residence to assist with the individual's health needs, and to be able to aid at the village hall during storm outages. CLR reported on the train derailment and all the departments did a fantastic job, and the department had 2 other calls to assist at the same time. Brian Miller stated he received a call from CP rails regarding the train derailment. Sheriff Dale Schmidt had great praise for all departments and CP rail. Life star report was not available at board meeting. National Night Out plans are all going well. National Night out will be held August 1, 2023, from 5-8pm. The 4-H group will provide food, DJ music, petting zoo, bounce house and more, mark your calendars for this event.

Library report: Jake Pacala gave the report from the monthly Library meeting, the standard operating procedure with the library went well, the summer program was taken out of text, and Jake will be checking on foundation repairs for the library. Brian will appoint the new library/village liaison for the library board next month. Brian Miller addressed that the village doesn't need to provide the library written documentation regarding the building.

Utility report: Outdoor meters were tabled. Ken Hanks reported that WE will open a case and begin an investigation on the power outages, and this could take up to 2 months. Ken will keep contacting WE if the power keeps flickering or continue with power outages.

Streets: Discussed the 35mph signs need to be moved. Weeds need to be mowed on tree boarders.

Finance & Personnel: A motion by Dave Snow to approve Class A Retailer's License for the sale of fermented malted beverage and intoxicating liquors for Sam's Amoco (Subhash M Patel-Agent) and Minn's General Store (Kyle L Minnameier-Agent), the motion was seconded by Jim Bublitz, motion carried.

A motion by Dave Snow to approve Class B Combination License for the sale of fermented malt beverage and intoxicating liquors for Reeseville Community Center (Denise Beal-Agent) and Just 1 More LLC (Michael Pocius-Agent), the motion was seconded by Kevin Hanks, motion carried.

A motion by Dave Snow to approve Cigarette and Tobacco products retail license for Sam's Amoco (Subhash M Patel-Agent), the motion was seconded by Jim Bublitz, motion carried.

A motion by Dave Snow to approve Operator Licenses for

The motion was seconded by Jacob Pacala, motion carried.

A motion by Dave Snow to approve Mobile Home Park License for Reeseville Acres WI MHC, LLC and Sunny Creek Home LLC, the motion was seconded by Ann Volkova, motion carried.

Nothing to report on the PUD and PES Real Estate LLC project.

Clerk update: Margaret reported to the board that July 17<sup>th</sup> – July 21, 2023, will be a week of clerks training and that will be done virtual online, and on July 26, 2023, I will also be taking another virtual online clerk training. Margaret asked the board how they wanted to handle past due water/sewer bills that are more than 60 days past due and have been given 2 warnings for non-payment, the board decided to disconnect services on accounts that

are 60 or more days past due, and to let residents know that there are added fees to have services turned back on. All fees will need to be paid in full before services will be turned back on.

The board discussed Christine Abell request to not be compensated for helping the clerk periodically, the board decided to compensate Christine as a contractor, and keep track of her time, and compensate Christine at the end of the year. The board is grateful that Christine is willing to help Margaret, and feels Christine deserves something for her time.

Public Health Welfare: Jim Bublitz reported that a lot of garbage and recyclable were not picked up.

Public Property: Jim Bublitz and Jacob Pacala reported they both have been very busy tidying up the several different items including the bench at the baseball diamond, basketball hoops at the park, painted the poles at the library and community center, power washed the sign on Jackson Street. The sign at the library must be done and the bridge by the ball diamond needs work. Jacob also reported that the totem pole will be remove and the shrubs pulled out at the mini park and possibly the shrubs at the community center. The mini park playground equipment will be removed soon, just waiting on a date from Rennhack Construction (Mike Rennhack), and the dumpster is ordered, the village will have to pay for the dumpster upfront and then be reimbursed when the village receives the grant money.

Dave Snow reported that people were driving around the fence at the brush pile with 4 wheelers and dumping items on brush pile, and suggested we look at the ordinance and make the fine higher to send a strong message.

Jacob Pacala addressed the post on fb regarding mailboxes for individual homeowners, Jacob reached out to Crystal from Columbus Post Office, Crystal thought it was with a village ordinance, if the village doesn't have an ordinance, it could open the door. Jacob Pacala made a motion to make a statement to the post office stating the village does not have an ordinance pertaining to restrictions of mailboxes, the motion was seconded by Anna Volkova, motion carried.

Community Center: Brian Miller handed out the community center report. Dave Snow reported bingo is going well, and the attendance for May was 140, June 120, and July 120. The progressive jackpot will be over \$2000 for August.

Utility report: Ken Hanks stated numerous days the blower was going out, and he placed a fan by the control panel which seems to have made a difference. Ken reported we had power outages on the 24 and 25. Ken stated we need a generator for the lift station and presented a bid for a generator like the prairie street lift station, bid from United and bring the bids back next month for the board's decision. Dave Snow reported Ken is doing a very good job. Dave Snow reported that Ken's health insurance premium of \$606 is supposed to be paid by the village as part of his contract.

Recreation Dept: No new update on the grant.

Committee reassignment will be done next month.

Future agenda items, The PUD/Pilot development, Update on Rezoning 500 South Main Street, Appointment to Library board Liaison, update on meeting with US Cellular.

A motion to approve paying the bills was made by Jim Bublitz and seconded by Jacob Pacala, motion carried.

A motion to adjourn was made by Dave Snow and seconded by Jim Bublitz, motion carried.
