Larry Ludtke

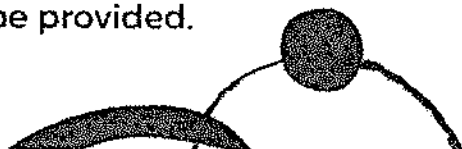

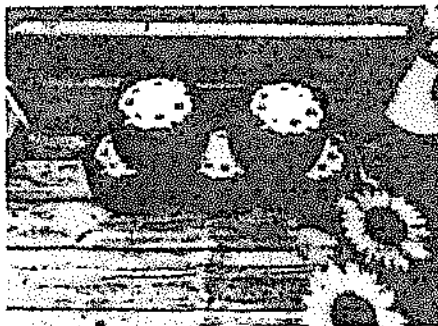

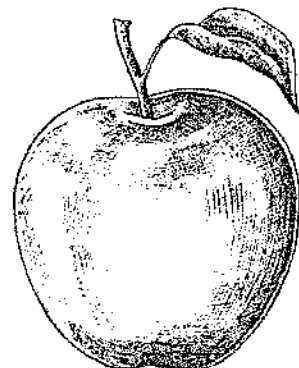

**PROCEEDINGS OF THE VILLAGE BOARD
OF THE VILLAGE OF REESEVILLE
August 10, 2023**

A duly convened meeting of the Village Board of the Village of Reeseville, Dodge County, Wisconsin, was held in open session on August 10, 2023, and called to order by Village President, Brian Miller, at 6:30pm. The pledge of allegiance was recited. Roll call was taken, and the following Trustees were present, Anna Volkova, Dave Snow, Jim Bublitz, Jacob Pacala, Kevin Hanks, Cheryl Goodrich.

Notice of the meeting was given to the public at least 48 hours prior to the meeting by posting the complete agenda at the Reeseville Village Hall, the Reeseville Post Office.

Jim Bublitz made a motion to approve the consent agenda, the motion was seconded by Kevin Hanks, and the motion carried.

Public comment: Joe Mauseth asked the boards permission to take the tree down on the boulevard. The tree had a big limb come down in a recent storm, and the tree is rotten in the center. Joe Mauseth had researched the ordinance and state statue, and after researching the information would like the approval of the village board to have the rest of the tree taken down. Brian Miller village president gave Joe the approval to take down the rotten tree, and the village board Anna Volkova, Cheryl Goodrich, Dave Snow, Jim Bublitz and Keving Hanks all agreed, Jacob Pacala was not present for this part of the board meeting.

Dave Fields from Beaver Dam is the potential buyer for the property of 500 South Main Street, Dave expressed to the board that he is interested in buying the property but would need the property to be rezoned for him to get the loan. Dave let the board know he has been working on cleaning up the property, and his plans for the property would be to restore the building and make it habitable. Dave Snow asked if they would just be living there, and Dave Fields said yes, he plans on living there with his wife. The public property committee had an earlier meeting and recommended moving forward to potentially rezone the property.

item # 11a on the agenda was moved up with the board's approval. Donna from Dodge County Housing Authority was present to give an update on the PILOT, the program is moving along, still working out details. Donna handed out the Income Approach to Value for the Reeseville Housing Development. Tom with the PILOT explained the Income Approach to Value handout to the board, and the difference with the cap rate. The board asked questions and has scheduled a Finance and Personnel Committee meeting for August 22, at 5pm to discuss more with Donna and Tom regarding the Pilot.

No Engineer Report

Police Report: Sergeant Derek Tritt was present to give the police report, total hours worked for the month of July were 42, total incidents were 33 and 30 total non-contract incidents. The calls consisted of building/area check, welfare check, ordinance violation, assist agency, traffic, gas drive off, animal, and parking. A handout from the Dodge County Sheriff's Office was given to each board member regarding license plate readers. The county is currently in the process of implementing the installation of automatic license plate readers throughout the county. These new technologies are being used throughout the entire country and they have greatly assisted law enforcement in solving crimes and recovering stolen property. The cost per camera is \$2,750.00 per year. The county is reaching out to our local businesses and community

stakeholders for donations to help offset the cost of these large-scale budget items. All who donate will be recognized publicly via our sheriff's office app and social media pages.

CLR Report: No report available. Jim Bublitz and Jake Pacala will be sweeping out the station with the police car and Lifestar vehicle in to help tidy up things. Jim Bublitz informed the board the police squad will be in the garage on August 28th for recall repairs.

National Night Out: Jim Bublitz reported the attendance was down slightly. Jim thanked everyone who attended and everyone who worked to make the night successful. Jim Bublitz and Jacob Pacala will be heading up the committee for next year.

Library Report: A motion was made by Dave Snow to appoint Jacob Pacala as the new liaison to the library/village board representative, the motion was seconded by Jim Bublitz, motion carried. Jacob Pacala reported that all members of the library board are approved by the village board, and the Library Director is approved by the library board. Jacob Pacala informed the village board he didn't have any updates on the library foundation and will be contacting basement companies to check the foundation out and will have a report next month.

Utility Report: Ken Hanks reported a water leak on North Main Street, Ken thought it seemed to be coming from a valve, they turned the water valve off and it still was leaking, so Ken will be calling Town & Country to come out. Ken reported Well #1 the phosphate scale went bad, and it still is under warranty and parts are ordered. Ken went over the estimates with the board for a new generator, the first estimate was from United for \$29,900.00 and the second estimate was from Rhodes Electric for \$24,500.00, the estimates include installation. A motion was made by Jim Bublitz to accept/hire Rhodes Electric for \$24, 500.00, the motion was seconded by Cheryl Goodrich, motion carried. Ken reported he signed up with Wisconsin Rural Water schooling in October from the 9th – 12th, each class cost \$110.00 each and then on October 17th will be the exam review and the cost for that class is \$110.00. Margaret Schmidt Clerk-Treasurer will get Ken's classes and hotel expenses taken care of by Saturday August 12, 2023. The board told Ken to flush all the fire hydrants, because they haven't been done yet.

Streets and Alleys: The streets and Alley Committee meeting will be held on August 21, 2023, at 2pm to discuss snow plowing bids for 2023-2024 season, US Cellular contract, and future street project projections. Ken Hanks reported that he hasn't heard anything about having the streets cleaned and will check with other companies. The lines on the street at the community center for parking need to be painted and Ken will work on getting this done. Jacob Pacala gave a brief update on mailboxes and home delivery; Jacob will be checking into this more.

Finance and Personnel Report: New Committee Reassignments were made out by Village President Brian Miller.

A motion was made by Dave Snow to approve renewing the loan documents for \$291,219.97, the motion was seconded by Jim Bublitz, motion carried.

Dave Snow reported for the Finance and Personnel committee, on the reviews of Clerk-Treasurer Margaret Schmidt and DPW Kenneth Hanks, and the committee members feel Margaret and Kenneth are doing a good job and encouraged both individual to keep up the good work.

Clerk Update: Margaret Schmidt reported on the schooling the week of July 17-21, 2023, Margaret said it was well worth the week training and learned several new things and look forward to next years training. Margaret also attended a 2-hour class on the 26th of July and learned several new things from those classes. Margaret reported to the board that we had several past due water/sewer bills and Margaret sent out disconnection notices on the 7th of August, and customers have 10 days to pay or make payment arrangements or their services will be disconnected. The board agreed if the bills were not paid to shut their services off.

Letter Of Intent Notification: The board reviewed the Letter of Intent Notification for land division in the Town of Lowell, Dave Snow made a motion to send the letter back as no recommendation from the village of Reeseville, Jim Bublitz seconded the motion, motion carried.

Public Property: Village property maintenance Jim Bublitz and Ken Hanks have been going around and checking village buildings for maintenance updates before budget time. Jim Bublitz contacted the hospital about selling the library building, Jim will wait to hear back from the hospital. Jim Bublitz made a motion to let the library store some limited items in the back office behind clerks' office and to keep that as an office space, the motion was seconded by Anna Volkova, motion carried. The shed door at the village cemetery building has been repaired. The brush pile is getting full after the recent storm damage, the board discussed checking out the chipper to see if we can mulch up some of the brush. Jacob Pacala reported cleaning out the little creek at the park of all kinds of debris. Farmers Market is going well, and vendors are happy with sales.

Community Center report: The board reviewed the financial and bookings report.

Recreation report: Anna Volkova reported she contacted another playground equipment company but will be staying with the first company she has been working with.

Future agenda items: Pilot, Electronic recycling, Contract with Hospital, US Cellular Contract

A motion to approve paying the bills was made by Jim Bublitz and seconded by Jake Pacala, motion carried.

A motion to adjourn the meeting was made by Jim Bublitz and seconded by Kevin Hanks, motion carried.
