





WASHINGTON — The U.S. Army will celebrate its 250th birthday on June 14, 2025, commemorating the Army's distinguished service to our nation. The central theme for this year's celebration is "This We'll Defend."

"As we prepare for our future, we also reflect on our past," said Gen. Randy George, Chief of Staff of the Army. "'This we'll defend' was first used as a battle cry by the Continental Army. Today it reminds us that our Army's purpose is clear: to fight and win the nation's wars. We remain committed to honing our warfighting skills, enforcing standards and discipline, and living the values that have defined our Army culture for the past 250 years."

As we enter 2025, the Army's 250th birthday will be celebrated with a series of commemorations, including leadership engagements, community outreach events and other events showcasing Army units, history, lineage and esprit de corps.

Established on June 14, 1775, the Army is a year older than the United States itself. Since its establishment, Army Soldiers, families and civilians have supported our nation, bearing true faith and allegiance to the country, the Constitution, their units and fellow team members as they defend the nation and provide assistance in times of need, including disaster relief and recovery efforts.

For 250 years, the U.S. Army has offered endless possibilities and opportunities for service to our nation. **PROCEEDINGS OF THE VILLAGE BOARD
OF THE VILLAGE OF REESEVILLE MAY 8, 2025**

A duly convened meeting of the Village Board of the Village of Reeseville, Dodge County, Wisconsin, was held in open session on May 8, 2025, and called to order by Village President, Jake Pacala, at 6:30pm. The pledge of allegiance was recited. Roll call was taken, and the following Trustees were present, Cheryl Goodrich, Jim Bublitz, Sean Laylin, Jessica Becker, Kevin Hankes, Anna Volkova.

Notice of the meeting was given to the public at least 48 hours prior to the meeting by posting the complete agenda at the Reeseville Village Hall, the Reeseville Post Office.

A motion to approve the consent agenda was made by Jim Bublitz, motion was seconded by Anna Volkova, motion carried.

Jim Bublitz made a motion to approve the minutes with the correction of Sergeant Kulibert name, the motion was seconded by Cheryl Goodrich, and the motion carried. A motion by Jim Bublitz to accept the treasurer report, motion was seconded by Anna Volkova, motion carried. A motion by Anna Volkova to accept the utility treasurer report, motion was seconded by Kevin Hankes, motion carried.

Public comment: William Demro would like to possibly start a small business to repair guns, and asked what is required by the village and ordinances. William informed the board he has been doing research on the state and federal level as well.

Engineer Report: Tammy Hampton informed the board that the Garfield Avenue project will begin late August or early September. The tree contractor will be cutting the trees down. Jessica Becker suggested having the Schuett's sign something about they are responsible for any damage the trees may cause from not being removed with the Garfield Avenue project. The Library Pre-Bid meeting will be Wednesday May 14, 2025, at 10am. June 12, 2025, at 5pm will be the project kick off for the library. Garfield Avenue Street project financing was discussed, and Jim Bublitz made a motion to approve borrowing \$650,000.00 for 5-year loan, 5.135% tax equivalent rate with up to 15-year amortization and ¼ pt loan fee at Farmers Merchant State bank in Waterloo, the motion was seconded by Jessica Becker, motion carried. The CLR lease agreement with the Village of Reeseville was discussed and will have more information next month.

Police Report: Sergeant Mayer gave the police report. The village board discussed parking permits, the parking permits are for 24-hour parking and the cost will be \$25 for residents and \$35 for non-residents, the permits will be printed with a date and time on them. A motion by Anna Volkova to approve the 24-hour parking permits and seconded by Jessica Becker, motion carried. Outstanding parking citations were discussed, and Margaret informed the board there are 3 unpaid citations outstanding and certified letters were sent to the residents. Kevin updated the board on 106 North Avenue compliance deadline, the letter was hand delivered, deadline is May 12, 2025, and May 19th, 2025, is cleanup day. Kevin has lined up the law enforcement and tow trucks. National Night Out update, a committee is being formed to help with the planning of the event, and more information will be available in June.

CLR Report: No report available.

Life star Report: No report. Mike is still working on the paging issues. Security cameras were tabled

Library Report: A formal meeting to approve the contract for the grant will be held shortly. The board reviewed the library report.

Utility Report: Ken reported Well #1 is down since last Friday. A small chlorine leak wrecked the motor and will have to be replaced. The ponds are doing good. A heater in the ferric building burnt up after 1 year and the building will need an exhaust system. Ken thanked Joe Wagner for the work he did at the mini park.

Streets and Alleys: Jim Bublitz made a motion to approve Thunder Roads to fill the potholes in the village limits for \$4,000. The Juneau Street Sweeper will clean the streets in May.

Finance and Personnel Report

Clerk Update: Margaret asked the village board on how to handle a phone line on the TDS bill that was used as a non-emergency contact line for CLR and currently is active and has an outstanding amount owed to the village, CLR changed to a new phone number and a different provider, and this transition took place in December of 2024.

Water/Sewer Treasurer Update: Kassie reported she attended a workshop for water and sewer utilities and learned a lot of new things. Kassie is working with workhorse co. and hoping to have everything in place before the next billing cycle. Kassie also would like to sit down with Don and Tammy from Kunkel Engineering and go over water and sewer questions. The village board discussed the US Cellular account and Margaret and Kassie informed the board that the auditors recommended that only village employees be on the village account, and non-employees be notified and given 30 days to remove their phone lines, or they would be turned off and become village property.

Jim Bublitz made a motion to pay the new RCC manager Deb Hardman \$20.00 an hour, the motion was seconded by Sean Laylin, motion carried. Jim Bublitz made a motion that all money and bill paying go through the village treasurer for the RCC, and the RCC checking account be closed, and all money in the checking account be transferred to the RCC savings account, the motion was seconded by Jessica Becker, motion carried

Public health and Welfare: The Public Property committee recommendation for sidewalk repair is to notify property owners whose sidewalk's need repairs and give them 1 year to fix their sidewalks. Cemetery plot survey bids were from Kunkel engineer for \$3,500 and a bid from New Frontier for \$2,200, Jim Bublitz made a motion to go with New Frontier for \$2,200 for the new part of the cemetery and marking the plots, the motion was seconded by Anna Volkova, motion carried.

Public Property: Jake Pacala explained that he changed the names of each committee to better serve each committee. New committee assignments have been updated. Jake asked that agenda items be to the clerk's office on Friday prior to the week of the board meeting. Cheryl Goodrich made a motion to approve Nathan Anton to mow the cemetery for \$250 each time and trimming for \$175, the motion was seconded by Sean Laylin, motion carried. Jake Pacala contacted the Clyman Cannons baseball organization regarding potentially using our baseball diamonds. The board also discussed kickball potentially being played in the small diamond area.

Community Center report: Cheryl Goodrich reported the RCC held election of officers and Cheryl Goodrich is President and Kay Kromm is Vice President and Ruth Snow is secretary. The RCC board is looking for new members to be on the board. The RCC board discussed new ideas and events to possibly be hosted at the RCC. The floor waxing was tabled. The next RCC meeting will be June 5th, 2025, at 5pm.

Future agenda items: Well #1, Doors at Well #2, exhaust system at Well #2, Gravel at sewer plant, Kubota tractor purchase, Utilities 2 mower, Village welcome sign & park signs.

Jim Bublitz made a motion to pay the bills and Jessica Becker seconded the motion, motion carried. Jim Bublitz made a motion to adjourn the meeting, Cheryl Goodrich seconded the motion, motion carried.
