**PROCEEDINGS OF THE VILLAGE BOARD  
OF THE VILLAGE OF REESEVILLE JULY 10, 2025**

A duly convened meeting of the Village Board of the Village of Reeseville, Dodge County, Wisconsin, was held in open session on July 10, 2025, and called to order by Village President, Jake Pacala, at 6:30pm. The pledge of allegiance was recited. Roll call was taken, and the following Trustees were present, Jim Bublitz, Sean Laylin, Jessica Becker, Kevin Hanks, Anna Volkova, Jacob Pacala. Absent Cheryl Goodrich.

Notice of the meeting was given to the public at least 48 hours prior to the meeting by posting the complete agenda at the Reeseville Village Hall, the Reeseville Post Office.

A motion to approve the consent agenda was made by K. Hanks, motion was seconded by J. Bublitz, motion carried.

Jim Bublitz made a motion to approve the minutes, the motion was seconded by Kevin Hanks, and the motion carried. A motion by Jim Bublitz to accept the treasurer report, motion was seconded by Jessica Becker, motion carried. A motion by Jessica Becker to accept the utility treasurer report, motion was seconded by Kevin Hanks, motion carried.

**Public comment:** Todd Greco, the new Dodge County District Administrator introduced himself to the village board. Jeff Caine reported that County roads K, and G to S were being rebuilt.

**Engineer Report:** Tammy Hampton had no updates on the Garfield Street project. The tree removal will begin 7/11/2025 on Garfield Street. Library update, the porch work has started, Kay and staff are packing, and a temporary internet will be set up. McKee will start work the first or second week in August. CLR lease Jake sent documents to the village attorney to look over. Annexation petition Jim Bublitz made a motion to move forward with the annexation petition for parcel # 032-1014-2812-007, the motion was seconded by Sean Laylin, motion carried.

**Public Safety Report:** Lt. Waas gave the police report. Kevin Hanks reported notice has been sent to the owner on Jackson Street to remove all vehicles on the property that are in non-compliance with the village ordinance. Fred Prough's appeal decision was ruled in favor of the village. National Night Out will host the State Patrol, Dodge County Sheriff Dept, CLR, 4-H organization and bouncy house for the kids. Lifestar no report available.

**CLR Report:** No report available.

**Life star Report:** No report available.

**Library Report:** Packing the collection of books for remodeling and moving to the temporary location, the furniture will be moved shortly, Morgana has been moving all the books. The number of library patrons has dropped this month.

**Infrastructure Report:** Ken reported on the storm damage at the MSAB tank. The storms have been causing problems at the ponds. Jake will reach out to Paul from Specialty Cheese for assistance with continued issues at the ponds. The tractor was tabled. Well #1 repairs are done. Well #2 Jessica has paint that can be used. The diffuser was tabled. Jim Bublitz reported on the storm damage on village property, and the RCC, Library, Barbershop will get roofs replaced. The tree in the park had \$1,500 damage, the metal roofs and doors not covered. The rubber roof on the village hall is fine.

**Administration Report:**

**Clerk Update:** Margaret reported Kassie and I will be in training July 14-18, 2025. I need a new board member employment form so payroll can be done. The village is currently on a spending freeze. I will be out of the office July 31, 2025, for personal business.

## Administration Report (continued)

**Water/Sewer Treasurer Update:** Kassie reported water & sewer bills went out late because of problems with new software, and with the new software updates no credit card payments can be made, hoping to have this issue resolved by next billing cycle. Kassie asked for clarification on meter charges.

Jessica Becker made a motion to move the voting location to the Reeseville Community Center, the motion was seconded by Kevin Hanks, and motion carried.

**Health and Human Services:** Deb Hardman (manager) from the RCC was present and updated the village board on the landscaping being completed and Jeff Hardman had spent many hours on updating the current landscaping, Thank you Jeff. Deb reported that she was opposed to having the floor's done at this time at the RCC because of the cost and should be tabled until a later date with more funds available. The board agreed that was a good idea, and to postpone the floors until a later date. Deb reported she was receiving a lot of positive feedback and getting bookings and inquiries.

**Planning and Development:** Anna Volkova reported she had 2 tree removal bids, and she is waiting on the last one and will have it next month.

**Future agenda items:** Police report, National Night Out, Lifestar, security cameras, Tractor, Diffuser, Lawn, Resolution for annexation, CLR Lease, Update on voting move.

Kevin Hanks made a motion to pay the bills, and Jessica Becker seconded the motion, motion carried. Jim Bublitz made a motion to adjourn the meeting, Kevin Hanks seconded the motion, motion carried.
